**DECISION:**

2359157 Ontario Inc.'s holistic centre owner's licence (No. B30-4311258) will be renewed and Anthony Forgione's application for a holistic practitioner's licence (Application No. B543399) will be issued, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence/application will be cancelled;
- (2) Immediately upon being issued and granted, the licences will be placed on probation for a period of four (4) years to commence on May 26, 2016;
- (3) Prior to each of the next four renewals of the licences, Anthony Forgione must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his criminal record;
- (4) During the probationary period, if 2359157 Ontario Inc. or Mr. Forgione incur any new charges or convictions under the *Toronto Municipal Code* or the *Criminal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days.
