TORONTO LICENSING TRIBUNAL: January 19, 2017 Summary of Decisions A.N. Alibhai / M. Laverty / A. Walsh

1. Mohamed Sardeye Mohamed (Report No. 6633) Applicant for a Taxicab Driver (Vehicle-For-Hire) Licence (Application No. B650097)

DECISION:

The Tribunal deemed Mohamed Sardeye Mohamed's application (No. B650097) as abandoned.

(Mohamed Sardeye Mohamed failed to attend today's hearing).

2. Dawit Habte Fikremichael (Report No. 6661) Applicant for a Vehicle-For-Hire Licence (Application No. B654558)

DECISION:

The Tribunal adjourned this matter to February 23, 2017.

 Abebe Gebreys (Report No. 6336) Holder of Taxicab Driver (Vehicle-For-Hire) Licence No. D01-3501484

DECISION:

The Tribunal approved the following jointly Proposed Resolution:

Abebe Gebreys' taxicab driver (vehicle-for-hire) licence will have the following conditions imposed, effective immediately:

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;

- (2) The licence shall be immediately suspended for a period of two (2) days, to commence on January 19, 2017; and the licensee must surrender his taxicab driver's licence and photo card on that date; the licensee may pick up his licence and photo card at 3:30 p.m. on January 20, 2017;
- (3) Prior to each of the next two (2) renewals of the licence, Mr. Gebreys must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6336, and any updating material, shall be brought back before the Tribunal for a full hearing.
