- (4) Prior to each of the next two (2) renewals of the licence, Mr. De Lambert must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record and criminal records check within 30 days of the licence expiry date, failing which the licence will be suspended until such document is received to the satisfaction of Municipal Licensing and Standards;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6372, and any updating material shall be brought back before the Tribunal for a full hearing.
