 Estate of Nathan Teye Asare (Report No. 6850) Kenneth Randall Reid on behalf of The Bank of Nova Scotia Trust Company, Estate Trustee Holder of Taxicab Owner's Licence No. V02-4653750 for Taxicab Plate No. 1349

DECISION:

The Tribunal extended taxicab owner's licence No. V02-4653750 for taxicab plate No. 1349 in the Estate of Nathan Teye Asare for a period of six (6) months.

 Servai Gurusamy Maniyaran (Report No. 6714) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B656342)

DECISION:

The Tribunal approved the following jointly Proposed Resolution:

A vehicle-for-hire licence will be issued to Servai Gurusamy Maniyaran, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of two (2) years to commence on March 1, 2017;

- 6. Hamid Fard (Report No. 6401) Holder of Taxicab Driver (Vehicle-For-Hire) Licence No. D01-3833351

DECISION:

The Tribunal approved the following jointly Proposed Resolution:

Hamid Fard's taxicab driver's (vehicle-for-hire) licence will be renewed, effective immediately, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Hamid Fard's licence shall be suspended for a period of seven (7) days to commence on March 1, 2017; the licensee must surrender his taxicab driver's licence and photo card on that date;
- (3) The licence will be placed on probation for a period of three (3) to commence on March 1, 2017;
- (4) Prior to each of the next three (3) renewals of the licence, Mr. Fard must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;

- (4) Immediately upon being issued, the licence will be placed on probation for a period of one (1) year to commence on March 1, 2017;
- (5) Prior to the next renewal of the licence, Mr. Slaney must provide to Municipal Licensing and Standards, at his own expense, an original upto-date abstract of his criminal record;
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against The Loaded Dog Sports Bar & Pub Inc. and Mr. Slaney, those matters and report No. 6754, and any updating material, may be brought back before the Tribunal for a full hearing.
