TORONTO LICENSING TRIBUNAL: May 18, 2017 Summary of Decisions M. Laverty / A.N. Alibhai / Dr. (Hedy) A. Walsh

1. Temal Ryan Gilbert (Report No. 6729) Applicant for a Tow Truck Drive's Licence (Application No. B676429)

DECISION:

The Tribunal adjourned this matter to August 3, 2017.

(Mr. Temal Ryan Gilbert failed to attend today's hearing).

 Violet Blonde Inc. (Report No. 6827) Sergio Varone, President Holder of Personal Services Settings Licence No. B56-4200137

DECISION:

Report No. 6827 was withdrawn by Municipal Licensing and Standard.

3. Nayron Gibran Haniff (Report No. 6821) Applicant for a Tow Truck Driver's Licence (Application No. B692494)

DECISION:

The Tribunal deemed Mr. Nayron Gibran Haniff's application No. B649245 as abandoned.

(Mr. Haniff failed to attend today's hearing)

4. Angellos Malamas (Report No. 6777) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B683727)

DECISION:

The Tribunal adjourned this matter to July 13, 2017.

(Mr. Malamas did not attend today's hearing)

5. Nadeem Iqbal (Report No. 6767) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B684059)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

A Vehicle-For-Hire Driver's licence will be issued to Nadeem Iqbal, effective immedialey, subject to the following contditions:

- (1) Before the licence is issued, Mr. Iqbal must provide to Municipal Licensing and Standards proof of payment of any overdue bylaw fines;
- (2) All fines, documents and/or any outstanding requirements, including proof of payment of overdue bylaw fines, must be submitted to the satisfaction of Municipa Licensing and Standards within 60 days of the Tribunal hearing, failing which the application/licence may be cancelled.

With the consent of all parties, the Tribunal ordered an amendment to paragraph 2: remove the words effective immediately.

6. Omotoni Akintoye (Report No. 6870) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B710077)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

A Vehicle-For-Hire Driver's licence will be issued to Omotoni Akintoye, effective immedialey, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municpal Licensng and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of one (1) year;
- (3) Prior to the next one (1) renewal of the licence, Mr. Akintoye must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;

(4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Omotoni Akintoye, those matters and report No. 6870, and any updating material, may be brought back before the Tribunal for a full hearing.

7. 685755 Ontario Inc. (Report No. 6861)

o/a Pizza Pizza #75 Jacek Zebrowski, President Applicant for an Eating Establishment Licence (Application No. B705779)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

An Eating Establishment licence will be issued to 685755 Ontario Inc., o/a Pizza Pizza #75, effective immediately, subject to the following conditons:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Before the licence is issued, Mr. Zebrowski must provide to Munipcal Licensing and Standards proof of payment of any overdue bylaw fines registered against 685755 Ontario Inc. and Jacek Zebrowski;
- (3) The licence will be suspended for a period of five (5) days on the following dates: May 29, June 5, June 12, June 19, and June 26.
