# TORONTO LICENSING TRIBUNAL: September 7, 2017 Summary of Decisions A.N. Alibhai / M. Calderwood / D. Simon

# 1. The Estate of Mustafa Negah (Report No. 6917)

Ms. Nadia Negah, Estate Trustee Holder of Taxicab Owner's Licence No. V02-4701240 for Plate No. 1644

#### **DECISION:**

The Tribunal extended taxicab owner's licence No. V02-4701240 for taxicab plate No. 1644 in the Estate of Mustafa Negah for a period of ten (10) months to June 11, 2018. (The extension is from the date of the expiry of the last extension, which was on August 11, 2017)..

- (3) Prior to each of the next three (3) renewals of the licence, Thushanthan Shanmugarajah must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;

Dave's Taxi Ltd will surrender Taxicab plate No.482 to Municipal Licensing and Standards on September 11, 2017 at 8:00 a.m. and will retrieve it on September 20, 2017 at 3:30 p.m.
