## TORONTO LICENSING TRIBUNAL: April 30, 2015 Summary of Decisions (Hedy) A. Walsh / M. Calderwood / T. Yao

## 1. 1772858 Ontario Inc.

o/a Oriental Food Mart (McCowan) (Report No. 6087) Gui Xian Li, President Holder of Retail Food Store Licence No. B50-3846225

## **DECISION:**

The Tribunal approved the following joint settlement:

1772858 Ontario Inc. (the "Applicant") admits all facts contained in Report No. 6087 (the "Report") dated July 18, 2014.

1772858 Ontario Inc.'s retail food store licence will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of four (4) years to commence on April 30, 2015;
- (2) prior to each of the next four (4) renewals of the licence, 1772858 Ontario Inc. must provide to Municipal Licensing and Standards, at its own expense, an updated abstract of its criminal record;
- (3) during the probationary period, if 1772858 Ontario Inc. incurs any new charges or convictions under the *Toronto Municipal Code*, the *Criminal Code* and/or the *Health Protection and Promotion Act* and its regulations, in writing, within three (3) business days which can be done in the following ways:
  - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via email to mlsconditionreporting@toronto.ca; or
  - via fax at 416-392-3102
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6087, and any updating material, shall be brought back before the Tribunal for a full hearing.
- (5) 1772858 Ontario Inc. must abide by the holiday shopping bylaw under

the *Toronto Municipal Code*, Chapter 510, Subsection 2, ie. no person carrying on a retail business in a retail business establishment shall sell or offer any goods or services for sale on a holiday, or admit members of the public to the retail business establishment on a holiday (including New Year's Day, Family Day, Good Friday, Easter Sunday, Victoria Day, Canada Day, Labour Day, Thanksgiving Day and Christmas Day).
