1. Estate of Judith Goldberger (Report No. 6521)

Shirley Klein, Estate Trustee

Holder of Taxicab Owner's Licence Nos. V02-4534916, V02-4534919, V02-4534920, V02-4534921, V02-4534923 and V02-4534917 for Taxicab Plate Nos. 190, 581, 610, 1583, 1818 and 2606

DECISION:

The Tribunal extended taxicab owner's licence Nos. V02-4534916, V02-4534919, V02-4534920, V02-4534921, V02-4534923 and V02-4534917 for Taxicab Plate Nos. 190, 581, 610, 1583, 1818 and 2606 in the Estate of Judith Goldberger for a period of nine (9) months to December 16, 2016.

2. Steve Omar Ali (Report No. 6453)

Applicant for a Tow Truck Driver's (Application No. B538741)

DECISION:

The Tribunal adjourned this matter to February 11, 2016 peremptory on the applicant. Should Mr. Ali's representative not be available, he is to advise Toronto Licensing Tribunal staff no later than January 6, 2016.

3. Reje Perasanna Kulendranathan (Report No. 6502)

Applicant for a Limousine Driver's Licence (Application No. B542261)

DECISION:

Reje Perasanna Kulendranathan's limousine driver's licence will be issued, effective immediately, subject to the following conditions:

- (1) Municipal Licensing and Standards must ensure all the elements of the application are met, including the medical note and the licensing fee, before the licence is granted;

- (2) immediately upon being issued, the licence will be placed on probation for a period of four (4) years to commence on December 3, 2015;
- (3) prior to each of the next four renewals of the licence, Mr. Kulendranathan must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his driving record and criminal record check;
- (4) during the probationary period, if Mr. Kulendranathan incurs any new charges or convictions under the *Criminal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Kulendranathan can notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;

- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6502, and any updating material, shall be brought back before the Tribunal for a full hearing.
