
TORONTO LICENSING TRIBUNAL: February 23, 2017
Summary of Decisions

- 1. Shahab Goneh-Farahani** (Report No. 6609)
Applicant for a Tow Truck Driver's Licence (Application No. B647560)

DECISION:

The Tribunal approved the following jointly Proposed Resolution:

Shahab Goneh-Farahani's licence will be issued, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on February 23, 2017;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Goneh-Farahani must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Goneh-Farahani, those matters and report No. 6609, and any updating material, may be brought back before the Tribunal for a full hearing.

- 2. Anisan Anton** (Report No. 6704)
Applicant for a Tow Truck Driver's Licence (Application No. B656962)

DECISION:

Anisan Anton's licence will be issued subject to the following conditions:

- (1) The licence will not issue until Mr. Anton provides satisfactory proof to Municipal Licensing and Standards that he has attended and completed a defensive driving course;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of four (4) years to commence on the date of issuance;
- (3) During the four year probationary period:
 - Mr. Anton will be restricted from directly handling credit and/or debit cards of customers
 - Mr. Anton's tow truck driver's licence will carry an endorsement setting out this restriction
 - Mr. Anton will inform any tow truck company he may be employed by of this restriction
- (4) Prior to each of the next four (4) renewals of the licence, Mr. Anton must provide to Municipal Licensing and Standards, at his own expense, original up-to-date abstracts of his criminal record and driving record;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Anton, those matters and report No. 6704, and any updating material, may be brought back before the Tribunal for a full hearing.

3. Dawit Habte Fikremichael (Report No. 6661)

Applicant for a Vehicle-For-Hire Licence (Application No. B654558)

DECISION:

The Tribunal adjourned this matter tentatively to March 23, 2017, due to time restraints. If March 23rd is not available, the alternate date would be April 13, 2017.

4. Seyed Yaghoob Mohseni Mofidi (Report No. 6485)

Holder of Taxicab Driver's Licence No. D01-3117254

DECISION:

Seyed Yaghoob Mohseni Mofidi will have the following conditions imposed on his taxicab driver's licence, effective immediately:

February 23, 2017

- (1) The licence shall be immediately suspended for a period of fourteen (14) days, to commence on February 23, 2017; and Mr. Mohseni Mofidi must surrender his taxicab driver's licence and photo card by 10:00 a.m. on February 24, 2017;
- (2) The licence will be placed on probation for a period of four (4) years to commence on the date the licence is reinstated after the suspension;
- (3) Prior to each of the next four (4) renewals of the licence, Mr. Mohseni Mofidi must provide to Municipal Licensing and Standards, at his own expense, original up-to-date abstracts of his criminal record and driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Mohseni Mofidi, those matters and report No. 6485, and any updating material, may be brought back before the Tribunal for a full hearing.
