DECISION:

The Tribunal adjourned this matter sine die.

2. Carlos A. Hidalgo (Report No. 6243)

o/a Uptown Plumbing Holder of Plumbing Contractor's Licence No. T94-4311552; and Holder of Master Plumber's Licence No. T95-4311546

DECISION:

The Tribunal approved the following jointly proposed resolution, as amended:

Carlos A. Hidalgo's plumbing contractor's licence and master plumber's licence will have the following conditions imposed, effective immediately:

- (1) the licences shall be immediately suspended for a period of seven (7) days, to commence on June 18, 2015; and the licensee must surrender his plumbing contractor's licence and master plumber's licence and photo card on that date;
- (2) the licences will be placed on probation for an additional two (2) years to commence on June 18, 2015 and ending on October 17, 2019;
