**1. Estate of Muhammad Afzal (Report No. 6497)**

Jahan Zeb Afzal, Estate Trustee

Holder of Taxicab Owner's Licence No. V02-4430855 for Ambassador Taxicab  
Plate No. A505

**DECISION:**

The Tribunal extended Ambassador taxicab owner's licence No. V02-4430855 for taxicab plate No. A505 in the Estate of Muhammad Afzal for a period of nine (9) months to July 29, 2016.

**2. Estate of Farzad Bakhtiar (Report No. 6498)**

Holder of Taxicab Owner's Licence No. V02-4430658 for Taxicab Plate No. A468

**DECISION:**

The Tribunal extended Ambassador taxicab owner's licence No. V02-4430658 for taxicab plate No. A468 in the Estate of Farzad Bakhtiar for a period of nine (9) months from November 9, 2015 to August 9, 2016.

**3. Joe Youseph Rajab (Report No. 6314)**

Holder of Taxicab Owner's Licence No. V02-4316627 for Taxicab Plate No. 1388

**DECISION:**

The Tribunal transferred the conditions previously placed on Joe Youseph Rajab's taxicab driver's licence on October 24, 2013 to his taxicab owner's licence, effective immediately to October 24, 2016.

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on October 24, 2013;

- (2) prior to each of the next three renewals of the licence, Mr. Rajab must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his criminal record;
- (3) during the probationary period, if Mr. Rajab incurs any charges or convictions under the *Toronto Municipal Code* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days, which can be done in the following ways:

**4. Joseph Antwi-Dikopim (Report No. 6312)**

Holder of Taxicab Driver's Licence No. D01-2006097

AND

Applicant for Toronto Taxicab Licence (TTL) for Plate No. 4238 (Application No. B426932)

**DECISION:**

The Tribunal approved the following jointly proposed resolution:

Joseph Antwi-Dikopim's licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of two (2) years to commence on October 29, 2015;
- (2) prior to each of the next two renewals of the licence, Mr. Antwi-Dikopim must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Antwi-Dikopim incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Antwi-Dikopim can notify Municipal Licensing and Standards in one of the following ways:

The Tribunal approved the following jointly proposed resolution:

Sandeep Singh's licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on October 29, 2015;
- (2) prior to each of the next three renewals of the licence, Mr. Singh must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his driving record and criminal record;
- (3) during the probationary period, if Mr. Singh incurs any new charges or convictions under the *Toronto Municipal Code*, the *Highway Traffic Act* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Singh can notify Municipal Licensing and Standards in one of the following ways:

**DECISION:**

The Tribunal approved the following jointly proposed resolution:

Farid Hamidi's licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on October 29, 2015;
- (2) prior to each of the next three renewals of the licence, Mr. Hamidi must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Hamidi incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Hamidi can notify Municipal Licensing and Standards in one of the following ways:

**7. Muhammad Saad Madani** (Report No. 6484)  
Applicant for a Tow Truck Driver's Licence (Application No. B540414)

**DECISION:**

The Tribunal approved the following joint submission:

Muhammad Saad Madani's licence will be issued, effective immediately,

subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of four (4) years to commence on October 29, 2015;
- (2) prior to each of the next four renewals of the licence, Mr. Madani must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record, as follows:
  - February 29, 2016; June 29, 2016; and October 28, 2016 (renewal date);
  - February 28, 2017, June 29, 2017; October 27, 2017 (renewal date);
  - April 28, 2018 and October 29, 2018 (renewal date);
  - April 29, 2019 and October 29, 2019 (renewal date).
- (3) prior to each of the next four renewals of the licence, Mr. Madani must provide to Municipal Licensing and Standards, at his own expense, an updated criminal record check, as follows:
  - October 28, 2016; October 27, 2017; October 29, 2019 and October 29, 2019.
- (4) during the probationary period, if Mr. Madani incurs any new charges or convictions under the *Toronto Municipal Code*, the *Highway Traffic Act* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Madani can notify Municipal Licensing and Standards in one of the following ways:
