# TORONTO LICENSING TRIBUNAL: October 8, 2015 Summary of Decisions L. Marzinotto / A. Alibhai / A. Walsh

## 1. Estate of Abraham Morgenstern (Report No. 6480)

Ms. Gail Elaine Morgenstern, Estate Trustee Mr. Howard Morgenstern, Estate Trustee Holder of Taxicab Owner's Licence Nos. V02-4431140 and V02-4431141 for Taxicab Plate Nos. 959 and 2765

#### **DECISION:**

The Tribunal extended taxicab owner's licence Nos. V02-4432240 and V02-4431141 for taxicab plate Nos. 959 and 2765 in the Estate of Abraham Morgenstern for a period of nine (9) months.

## **DECISION:**

The Tribunal approved the following jointly Proposed Resolution:

1857257 Ontario Inc., o/a Royal Maple Spa, shall be issued a body rub parlour licence subject to the following conditions:

- The licence shall be immediately placed on probation commencing on the date that this Proposed Resolution is approved by the Toronto Licensing Tribunal and ending on May 22, 2019;
- (2) Ms. Xueling Ma cannot be involved in the operation of the business in any way, and can only be on site as required in her capacity as owner of the premises;
- (3) during the probationary period, if 1857257 Ontario Inc. or Mr. Lun Hui Wang incur any new charges or convictions under the *Toronto Municipal Code*, the *Highway Traffic Act* or the *Criminal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include their ML&S licence number and the ticket number(s). Mr. Wang can notify Municipal Licensing and Standards in one of the following ways:

## **DECISION:**

The Tribunal adjourned this matter *sine* die and approved the following jointly proposed resolution:

Moauzam Bhangoo will have the following interim conditions imposed on his licence, effective immediately:

- (1) If Mr. Bhangoo incurs any new charges or convictions under the *Criminal Code of Canada*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days, which can be done in the following ways:

- (3) Mr. Bhangoo must notify Municipal Licensing and Standards, in writing, of the disposition of the following charges:
  - Operation of a motor vehicle with 80 mgs. of alcohol (Offence date: January 27, 2015)
  - Impaired by alcohol or drug (Offence date: January 27, 2015)

within three (3) business days, which can be done in the following ways:
