TORONTO LICENSING TRIBUNAL: December 10, 2015 Summary of Decisions A. Alibhai / L. Marzinotto / C. Paluch

DECISION:

The Tribunal adjourned this matter to January 21, 2016.

 World Car Park Management Inc. (Report No. 6394) o/a World Car Park Management Surafel Bezabhe Mengistu, President Applicant for Public Garage – Parking Lot Licences (Application Nos. B305591 and B308919) Applicant for Commercial Parking Lot Licence (Application No. B543430)

DECISION:

The Tribunal approved the following joint submission:

World Car Park Management Inc.'s public garage – parking lot licences and commercial parking lot licence will be issued, subject to the following conditions:

- (1) The licences will be placed on probation for a period of 30 months to commence on the date of issuance;
- (2) During the probationary period, if World Car Park Management Inc. or Surafel Bezabhe Mengistu incur any new charges or convictions under the *Toronto Municipal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include their ML&S licence number and the ticket number(s). Mr. Mengistu can notify Municipal Licensing and Standards in one of the following ways:

- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6394, and any updating material, shall be brought back before the Tribunal for a full hearing.

- (3) Mr. Jahan must notify Municipal Licensing and Standards, in writing, of the disposition of the following charges:
 - Operation of motor vehicle impaired by alcohol or drug (Offence date: July 22, 2015)
 - Refuse to provide sample (Offence Date: July 22, 2015):

within three (3) business days which can be done in the following ways:
