# TORONTO LICENSING TRIBUNAL: February 16, 2017 Summary of Decisions A. Walsh / A.N. Alibhai

1. Taylor Kate Lyon (Report No. 6665)

Applicant for a Body Rubber's Licence (Application No. B652798)

#### **DECISION:**

The Tribunal approved the following jointly Proposed Resolution:

Taylor Kate Lyon's licence will be issued, effective immediately, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) The licence will be placed on probation for a period of three (3) years to commence on February 16, 2017;
- (3) Prior to each of the next three (3) renewals of the licence, Ms. Lyon must provide to Municipal Licensing and Standards, at her own expense, an original up-to-date abstract of her criminal record;
- (4) During the course of her employment as a body rubber, Ms. Lyon shall not be permitted, in any way, to possess, handle or process any member of the public's credit and/or debit card;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Ms. Lyon, those matters and report No. 6665, and any updating material, may be brought back before the Tribunal for a full hearing.
