# TORONTO LICENSING TRIBUNAL: May 28, 2015 Summary of Decisions T. Yao / D. Peacock / H.A. Walsh

# 1. Golden Bridge Imports Inc. (Report No. 6259)

o/a Golden Bridge Imports Mr. Raed Yousif Danial Applicant for a Public Garage Licence (Application No. B423344)

#### **DECISION:**

Application (No. B423344) for a public garage licence was withdrawn by the licensee.

## 2. Ruben Felix A. Soto (Report No. 5799)

o/a Alberto Barbershop Applicant for Renewal of Hair Salon Licence No. B56-3613278

#### **DECISION:**

The Tribunal approved the following jointly proposed resolution, as amended:

Ruben A. Felix Soto's licence will be issued, effective immediately, subject to the following conditions:

- (1) the licence shall be immediately suspended for a period of ten (10) days to commence on May 29, 2015;
- (2) the licence will be placed on probation for a period of three (3) years to commence on May 28, 2015;
- (3) prior to each of the next three renewals of the licence, Mr. Soto must must provide to Municipal Licensing and Standards, at his own expense, an updated criminal record check;
- (4) during the probationary period, if Mr. Soto incurs any new charges or convictions under the *Toronto Municipal Code* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:

## 3. Barkat Ali Noorani (Report No. 6197)
