DECISION:

The Tribunal approved the following joint settlement.

Philip Ralph Faulkner's licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of one (1) year to commence on March 19, 2015;
- (2) prior to the next renewal of the licence, Mr. Faulkner must provide to Municipal Licensing and Standards, at his own expense, an up-to-date record of his criminal convictions or charges;
- (3) during the probationary period, if Mr. Faulkner incurs any new charges or convictions under the *Toronto Municipal Code* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6303, and any updating material, shall be brought back before the Tribunal for a full hearing.
- (5) If the pending charge of Auctioneer No Licence results in a conviction, Mr. Faulkner must report it to Municipal Licensing and Standards.
