# 4. Cake Boys Entertainment Ltd. (Report No. 6318)

## **DECISION:**

The Tribunal adjourned this matter *sine die* (but no later than September 15, 2016), with the following interim conditions imposed, effective immediately:

- (1) Cake Boys Entertainment Ltd. shall continue to take steps to address the noise concerns raised by residents living in close proximity to its premises at 824 Dundas Street West, including but not limited to effectively monitoring both the volume of its entertainment system at all times and the behaviour of patrons outside of its premises during Studio Bar's operating hours;
- (2) Cake Boys Entertainment Ltd. shall ensure that the premises at 824 Dundas Street West are in compliance with its "restaurant" land use classification under the City of Toronto zoning bylaw;
- (3) Should Cake Boys Entertainment Ltd., or any of its officers, incur any new charges or convictions under the City of Toronto noise, zoning or licensing bylaws relating to incidents occurring after July 30, 2015, Municipal Licensing and Standards reserves the right, prior to the resolution of any outstanding bylaw charges, to bring any such new charges and an updated report No. 6318 before the Tribunal for a hearing.
