TORONTO LICENSING TRIBUNAL: March 17, 2016 Summary of Decisions L. Marzinotto / C. Paluch / A. Walsh

1. S.N. (Report No. 6216) Applicant for a Taxicab Driver's (Application No. B315715)

DECISION:

The Tribunal deemed S.N.'s application (No. B315715) for a taxicab driver's licence as abandoned.

(Mr. N. failed to attend today's hearing).

 Nail Art Ltd. (Report No. 6531) o/a Nails For You Cong Ky Dinh, President Applicant for a Personal Service Settings Licence (Application No. B542631)

DECISION:

The Tribunal approved the following jointly proposed resolution:

Nail Art Ltd.'s licence will be issued, effective immediately, subject to the following conditions:

- All fees required, documents and outstanding clearances must be submitted to the satisfaction of Municipal Licensing and Standards prior to the issuance of the licence(s);
- (2) Nail Art Ltd. (Mr. Cong Ky Dinh, President) must provide to Municipal Licensing and Standards proof of payment of any outstanding fines;
- (3) Immediately upon being issued, the licence will be placed on probation for a period of two (2) years to commence on March 17, 2016;
- (4) Prior to each of the next two (2) renewals of the licence, Mr. Dinh must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of criminal record;
- (5) During the probationary period, if Mr. Dinh incurs any new charges or

convictions under the *Toronto Municipal Code* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include the ML&S licence number and the ticket number(s). Mr. Dinh can notify Municipal Licensing and Standards in one of the following ways:

- in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;

- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6531, and any updating material, shall be brought back before the Tribunal for a full hearing.
- 3. Changsoo Hong (Report No. 6297)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3953088

DECISION:

The Tribunal approved the following jointly proposed resolution, **as amended**:

Changsoo Hong's taxicab driver's licence will be renewed, effective immediately, subject to the following conditions:

- All fees required, documents and outstanding clearances must be submitted to the satisfaction of Municipal Licensing and Standards prior to the issuance of the licences);
- (2) The applicant's licence shall be immediately suspended for a period of four (4) days, to commence on March 17, 2016; and the licensee must surrender his taxicab driver's licence and photo card on that date;
- (3) Mr. Hong must provide to Municipal Licensing and Standards proof of payment of any outstanding by-law fines before the date of the hearing, failing which the licence will be suspended until proof of payment of any outstanding fines is filed;
- (4) Immediately upon being renewed, the licence will be placed on probation until September 29, 2020 to commence on March 17, 2016;
- (5) Mr. Hong must provide to Municipal Licensing and Standards, every six(6) months until September 29, 2020, at his own expense, an original updated abstract of his driving record. The dates to submit are:

March 21, 2016 September 29, 2016 March 17, 2017 September 29, 2017 March 16, 2018 September 29, 2018 March 18, 2019 September 29, 2019 March 16, 2020 September 29, 2020

- (6) During the probationary period, if Mr. Hong incurs any new charges and/or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Hong can notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (7) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6297, and any updating material, shall be brought back before the Tribunal for a full hearing.

With the consent of all parties, the Tribunal ordered an amendment to condition No. 2: Mr. Hong must provide proof of payment of any outstanding fines; or provide documentation as proof for an application for Reopening of a Conviction, for the outstanding fine.
