TORONTO LICENSING TRIBUNAL: October 20, 2016 Summary of Decisions D. Simon / M. Calderwood / C. Paluch

1. Abdiaziz Ismail Omar (Report No. 6327) Applicant for Renewal of Taxicab Driver's Licence No. D01-3950372

DECISION:

The Tribunal approved the following jointly Proposed Resolution:

Abdiaziz Ismail Omar's taxicab driver's licence will have the following conditions imposed, effective immediately;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;
- (2) The applicant's licence shall be immediately suspended for a period of seven (7) days, to commence on October 20, 2016; and the licensee must surrender his taxicab driver's licence and photo card on that date;
- (3) Mr. Omar must provide to Municipal Licensing and Standards proof of payment of any outstanding by-law fines before the date of the hearing, failing which the licence will be suspended until proof of payment of any outstanding fines is filed;
- (4) Immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on October 20, 2016;
- (5) Prior to each of the next three (3) renewals of the licence, Mr. Omar must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record;
- (6) During the probationary period, if Mr. Omar incurs any new charges and/or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his Municipal Licensing & Standards licence number and the ticket number(s). Mr. Omar can notify Municipal Licensing and Standards in one of the following ways:

- (7) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6327, and any updating material, shall be brought back before the Tribunal for a full hearing.
- 2. Cartwright Custom Renovations Ltd. (Report No. 6115) Vincenzo Forgione, President/Trades Person Applicant for a Building Renovator's Licence (Application No. B312318)

DECISION:

Cartwright Custom Renovations Ltd.'s building renovator's licence will be issued, effective immediately, subject to the following conditions;

- (1) The licence will not issue until Mr. Forgione pays the outstanding fines located on page 6 of report No. 6115; or satisfies Municipal Licensing and Standards that he has entered into an appropriate agreement to repay those fines in the form of a payment plan;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on October 20, 2016;
- (3) During the probationary period, if Cartwright Custom Renovations Ltd. or Mr. Forgione, in his personal capacity, incur any new charges and/or convictions under the *Toronto Municipal Code* or the *Criminal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days, which can be done in one of the following ways:

- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6115, and any updating material, shall be brought back before the Tribunal for a full hearing.

3. Estate of Yeuk-Yu Peter Wong (Report No. 6722) Wai Ng Wong, Estate Trustee Holder of Taxicab Owner's Licence Nos. V02-4534316 and V02-4534317 for Taxicab Plate Nos. 793 and 3262

DECISION:

The Tribunal extended taxicab owner's licence Nos. V02-4534317 and V02-4534317 for taxicab plate Nos. 793 and 3262 in the Estate of Yeuk-Yu Peter Wong for thirty (30) days.

4. Jeffrey Barker (Report No. 6632) Holder of Tow Truck Driver's Licence No. D09-4417898

DECISION:

The Tribunal adjourned this matter for approximately three (3) months *sine die*; dates to be determined by mutual consent.

 Aziz Ahmad (Report No. 6707) Holder of Toronto Vehicle-For-Hire Driver's Licence No. D01-4431237

DECISION:

The Tribunal approved the following jointly Proposed Interim Conditions:

Aziz Ahmad will have the following interim conditions imposed on his Toronto Vehicle-For-Hire Driver's Licence, effective immediately;

- (1) Mr. Ahmad's driving privileges will be suspended such that he shall not drive a taxicab and transport passengers for hire in the City of Toronto;
- (2) Mr. Ahmad will surrender his licence and photo identification to Municipal Licensing and Standards at 850 Coxwell Avenue by Monday, October 24, 2016;
- (3) If Mr. Ahmad incurs any new charges or convictions under the *Criminal Code of Canada*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in one of the following ways:

- in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via email to mlsconditionreporting@toronto.ca; or
- via fax at 416-392-3102
- (4) If Mr. Ahmad incurs any new charges under the *Criminal Code of Canada*, Municipal Licensing and Standards reserves the right, prior to the resolution of any outstanding criminal charges, to bring any such new charges and an updated report No. 6707 before the Tribunal for a hearing;
- (5) Mr. Ahmad must notify Municipal Licensing and Standards, in writing, of the disposition of the current criminal charges or any change to his bail conditions within three (3) business days, which can be done in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;

 - via fax at 416-392-3102
- (6) At any point prior to the Tribunal's final disposition of this matter, Municipal Licensing and Standards or Mr. Ahmad may seek leave from the tribunal to amend the conditions imposed on the licence if the present facts or circumstances surrounding this matter change. The party requesting leave must serve notice of such request on the other party.
