TORONTO LICENSING TRIBUNAL: July 14, 2016 Summary of Decisions M. Calderwood / M. Laverty / R. Quan

1. Belal Mohammed Ahmed (Report No. 6559)
Applicant for a Taxicab Driver's Licence (Application No. B645250)

DECISION:

Belal Mohammed Ahmed's licence will be issued, effective immediately, subject to the following conditions:

- (1) Prior to the issuance of the licence, Mr. Ahmed must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his criminal record (to be provided within 30 days of the July 14, 2016 Tribunal hearing, failing which the application/licence will be cancelled);
