## TORONTO LICENSING TRIBUNAL: October 13, 2016 Summary of Decisions A.N. Alibhai / M. Calderwood / C. Paluch

- **2.** Ahmad Umair Dogar (Report No. 6635) Holder of Taxicab Driver's Licence No. D01-4536326

## **DECISION:**

Muhammad Umar Tariq's taxicab driver's licence (No. D01-4426857) and Ahmad Umair Dogar's taxicab driver's licence (No. D01-4536326) will be suspended until:

- A) Muhammad Umar Tariq:
  - i) all criminal charges relating to this matter are disposed of
  - ii) the matter is brought back before the Tribunal for determination.
- B) Ahmad Umair Dogar:
  - i) all criminal charges relating to this matter are disposed of
  - ii) the matter is brought back before the Tribunal for determination.

The Tribunal ordered Muhammad Umar Tariq and Ahmad Umair Dogar to surrender their taxicab driver's licences and photo identifications to Municipal Licensing and Standards, in person, at 850 Coxwell Avenue by 12:00 noon on or before Thursday, October 20, 2016.

The Tribunal further advised that if the documents cannot be surrendered, Mr. Tariq and Mr. Dogar are to complete the necessary Statutory Declaration forms, in person, at 850 Coxwell Avenue on or before Thursday, October 20, 2016. October 13, 2016

**3. John David Lambe** (Report No. 6576) Applicant for Tow Truck Driver's Licence (Application No. B646067)

## **DECISION:**

The Tribunal adjourned this matter *sine die* and advised Mr. Lambe that he should be prepared to proceed with the matter after February 13, 2017, whether or not his counsel is present, as the matter will not be adjourned a fourth time.
