# TORONTO LICENSING TRIBUNAL: May 5, 2016 Summary of Decisions R. Quan / A.N. Alibhai / A. Walsh

1. Muhammad Usman Asghar (Report No. 6533) Applicant for a Taxicab Driver's Licence (Application No. B540983)

#### DECISION:

The Tribunal approved the following jointly proposed resolution:

Muhammad Usman Asghar's licence will be issued, effective immediately, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of four (4) years to commence on the date of issuance;
- (3) Prior to each of the next four (4) renewals of the licence, Mr. Asghar must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record:
  - November 4, 2016
  - May 5, 2017
  - November 3, 2017
  - May 4, 2018
  - November 2, 2018
  - May 3, 2019
  - November 1, 2019
  - May 1, 2020

and a criminal record check at each renewal;

(4) During the probationary period, if Mr. Asghar incurs any new charges and/or convictions under the *Toronto Municipal Code*, the *Criminal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Asghar can notify Municipal Licensing and Standards in one of the following ways:

- in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
- via email to mlsconditionreporting@toronto.ca; or
- via fax at 416-392-3102
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6533, and any updating material, shall be brought back before the Tribunal for a full hearing.

**3. Yaser Qandeel** (Report No. 6537) Applicant for a Tow Truck Driver's Licence (Application No. B543871)

#### **DECISION:**

The Tribunal approved the following jointly proposed resolution:

Yaser Qandeel's licence will be issued, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of four (4) years to commence on the date of issuance;
- (3) Prior to each of the next four (4) renewals of the licence, Mr. Qandeel must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record every four (4) months for the first year:

  - January 5, 2017
  - May 4, 2017

- 4. Yaw Boakye (Report No. 6322)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3254484

#### **DECISION:**

The Tribunal approved the following jointly proposed resolution:

Yaw Boakye's licence will be renewed, effective immediately, subject to the following conditions:

- (1) The licence will be suspended for ninety (90) days. Mr. Boakye must surrender his licence and photo card to Municipal Licensing and Standards and may retrieve the documents when the suspension is completed.
- (2) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;

- (3) Mr. Boakye's licence will be placed on probation for a period of four (4) years to commence on May 5, 2016;
- (4) During the four (4) years probation, Mr. Boakye must provide to Municipal Licensing and Standards, at his own expense, an original driving record abstract every 3 months for the first year; and for the remaining 3 years of his probation, an original driving record abstract every 6 months;
- (5) Before Mr. Boakye retrieves his licence and photo card from Municipal Licensing and Standards, he must attend and pass a third party defensive driving course, at his own expense, that runs for a minimum of 2 days; and present a certificate of completion to Municipal Licensing and Standards;
- (6) During the probationary period, if Mr. Boakye incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Boakye can notify Municipal Licensing and Standards in one of the following ways:
