TORONTO LICENSING TRIBUNAL: April 21, 2016 Summary of Decisions A.N. Alibhai / C. Paluch / A. Walsh

1. Jin Wen Zhou (Report No. 5861)

Holder of Holistic Practitioner Licence No. T30-3619045 AND Suiki Health Beauty Centre Inc. Former Holder of Holistic Owner's Licence No. B30-4187982

DECISION:

The Tribunal adjourned this matter to August 4, 2016, on consent, *peremptory* to Mr. Jin Wen Zhou in order to allow him time to retain legal representation.

2. Saiyeed M. Baki (Report No. 6530)

Holder of Taxicab Driver's Licence No. D01-3617310; and Applicant for a Limousine Driver's Licence (Application No. B645733)

DECISION:

The Tribunal approved the following jointly proposed resolution:

Saiyeed M. Baki's licences will have the following conditions imposed, effective immediately:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;
- (2) The licences shall be immediately suspended for a period of ten (10) days, to commence on April 21, 2016; and the licensee must surrender his taxicab driver's licence and photo card on that date; and Municipal Licensing and Standards will hold the limousine driver's licence and photo card;
- (3) The licences will be placed on probation for a period of five (5) years to commence on April 21, 2016;

- (4) Prior to each of the next five renewals of the licences, Mr. Baki must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record;
- (5) During the probationary period, if Mr. Baki incurs any new charges and/or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Baki can notify Municipal Licensing and Standards in one of the following ways:

- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6530, and any updating material, shall be brought back before the Tribunal for a full hearing.

3. Kenny's Auto Collision Repairs Inc. (Report No. 6325)

o/a Kenny's Auto Collision Repairs Rocky Narine, President Applicant for Renewal of Public Garage Licence No. B68-4200185

DECISION:

The Tribunal approved the following jointly proposed resolution:

Kenny's Auto Collision Repairs Inc.'s public garage licence will be renewed, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;
- (2) Immediately upon being renewed, the licence will be placed on probation until November 14, 2017, to commence on April 21, 2016;
- (3) Mr. Narine must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his criminal record on the date of the hearing and November 14, 2017;
- (4) During the probationary period, if Kenny's Auto Collision Repairs Inc. or Mr. Narine incur any new charges and/or convictions under the *Toronto*

Municipal Code or the *Criminal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days.
