Shuyang Wang (Report No. 6800)

## **DECISION:**

The Tribunal approved the following jointly Proposed Resolution:

- (1) Mr. Shuyang Wang Driving Instructor's Licence will be suspended, effective immediately, until Mr. Wang provides proof of reinstatement of his Provincial Driving Instructor's Licence to Municipal Licensing and Standards:
- (2) If Mr. Wang is unable to provide proof of reinstatement of his Provincial Driving Instructor's Licence to Municipal Licensing and Standards by October 22, 2017, Mr. Wang's City of Toronto Driving Instructor's Licence will be revoked.
