<b>Purpose</b>	To authorize the Full and Final Release and Direction (the "Release") between the City and Auto Happy Inc. and 1738343 Ontario Inc. (the "Owners") at 1290 Finch Avenue West, Units 12 and 18, in full and final settlement of any and all claims as a result of the expropriation of the property to facilitate the construction of the Toronto-York Spadina Subway Extension Project (the "TYSSE Project").		
<b>Property</b>	Portion of 1280-1300 Finch Avenue West described as Parts 1 and 2 on Expropriation Plan AT2632539. Expropriation Plans shown on the attached Appendix "B".		
<b>Actions</b>	<ol style="list-style-type: none"> <li>1. Authorize the Release between the City and the Owners, substantially in accordance with the terms and conditions outlined in Appendix "A" and in the Confidential Attachment.</li> <li>2. The Confidential Attachment should remain confidential until there has been a final determination of all property transactions and claims for compensation related to the Project.</li> <li>3. Authorize the City Solicitor to complete the transactions on behalf of the City, including paying any necessary expenses and applicable HST, if any.</li> </ol>		
<b>Financial Impact</b>	<p>Funding for this Release, as set out in the Confidential Attachment, is available in the Council Approved TTC 2016 Capital Budget and TTC 2017-2025 Capital Plan within the Toronto-York Spadina Subway Extension Capital Project. Total property acquisition costs for the Project are shared by the Move Ontario Trust, the City and the Regional Municipality of York.</p> <p>The Deputy City Manager &amp; Chief Financial Officer has reviewed this DAF and agrees with the financial impact information.</p>		
<b>Comments</b>	<p>1280-1300 Finch Avenue West, located on the north-west corner of Finch Avenue West and Tangiers Road, is improved with two commercial condominium buildings and is registered as Metropolitan Toronto Condominium Corporation No. 863. 1290 Finch Avenue West located on the west side of Tangiers Road, north of Finch Avenue West, is improved with one commercial condominium building and is registered as Metropolitan Toronto Condominium Corporation No. 828.</p> <p>On February 7 and 8, 2011, City Council, in adopting Item CC3.4, authorized the expropriation of portion of 1280-1300 Finch Avenue West for the construction of the Finch West Subway Station bus terminal. Expropriation Plan AT2632539 was registered on March 1, 2011. The City took possession of the expropriated land on June 20, 2011. On May 25, 2011, DAF No. 2011-164, authorized the preparation, service and payment of the Offers of Compensation pursuant to the <i>Expropriations Act</i>.</p> <p>The Owners submitted a joint claim to the City as the Property is owned and operated by the same principal. The claim is for business loss and disturbance damages because of reduced visibility and restricted physical access from Keele Street due to the hoarding around the City's construction site and for increased cleaning costs caused by the dirt and dust from the City's construction activities.</p> <p>Negotiations have been on-going. A settlement has now been reached and upon payment of the compensation the Owners will withdraw its claim filed with the Ontario Municipal Board.</p> <p>TTC staff have reviewed the terms and conditions of the Release and concur with proceeding.</p> <p>City staff consider the terms and conditions of the Release to be fair and reasonable and are recommending its approval.</p>

**General Conditions (“GC”)**

- (a) The local Councillor (or local Councillors if the subject property is located on a ward boundary or if the transaction involves an exchange of properties in more than one ward), will be consulted prior to the exercise of delegated Approving Authority by staff for all Acquisitions, Disposals, Land Exchanges and Leases.
- (b) Where approving power has been delegated to staff, the Chief Corporate Officer, in consultation with the applicable Deputy City Manager or the City Manager, may determine that such matter is of such special interest that same should be returned to the relevant Committee and Council for consideration and determination.
- (c) Exercise of delegated authority is subject to all applicable Council policies, statutes or other applicable law.
- (d) Authority to approve financial commitments/expenditures is subject to all amounts being available in an approved budget [or funding is available from alternative sources].
- (e) Property interests are to be based on appraised value, and no interest shall be granted at less than market value unless otherwise specifically authorized.
- (f) Authority to approve transactions at less than market value is subject to statutory anti-bonusing provisions.
- (g) Total compensation means the aggregate of all types of payments, including land value, estimated clean-up costs, potential arbitration awards, loss claims, etc, but exclusive of any applicable taxes and registration costs.
- (h) Authority to acquire property is conditional upon provision being made to bring the property into compliance with applicable MOE or other requirements such that it will be fit for its intended municipal purpose.
- (i) Authority to initiate the permanent road closure process in **A.4** is conditional upon confirmation by the GM of Transportation Services that it is feasible to permanently close the highway.
- (j) Disposal authorities in **A.7** are subject to the property having been declared surplus, and the disposal policy complied with.
- (k) Land exchanges, except for those in **A.8**, may be authorized based on the delegated Approving Authority for Disposals in **A.7**.
- (l) Approving Authority with respect to land located in the Designated Waterfront Area is conditional upon the approval of the Director, Waterfront Secretariat.
- (m) Authority to approve an exchange of land in **A.8** is conditional upon confirmation by the Chief Planner and Executive Director, and the GM of Parks, Forestry & Recreation, that the land being exchanged is (i) nearby land of equivalent or larger area, and (ii) of comparable or superior green space utility.
- (n) Approving Authority in **A.9** Leases (City as Landlord) but not Licences (City as Licensor) is limited to periods (including options/renewals) of less than twenty-one (21) years.
- (o) Total compensation in leasing matters where the City is landlord (**A.9**) includes the value of tenant improvements if factored into tenant’s rental payments.
- (p) Total compensation in leasing matters where the City is the tenant (**A.10**) includes the value of any tenant improvements to be paid by the City.
- (q) Where options/renewals are included in leases, if the renewal rent is to be determined at a date later than the original approval date, total compensation is to be calculated as though all options are exercised, estimating the renewal rent based on the highest rent payable in the first term of the lease.
- (r) Total compensation in leasing matters where the City is landlord (**A.9**) or tenant (**A.10**) is to be calculated from the date of approval pursuant to this delegation (ie. first allowing for the expiry of any prior approvals, whether by Council or a delegated authority).
- (s) Approving Authority in leasing matters includes authority to approve renewals/extensions within the parameters of the delegated Approving Authority.
- (t) Approving Authority includes authority for amendments within the parameters of the delegated Approving Authority, the cumulative total of which may not exceed the delegated financial limit.
- (u) Where proposed additional amounts in **A.13** exceed 10 per cent of the original decision, even if otherwise in compliance with all other conditions, then approving authority is transferred upwards to the next more senior level of approving authority having the relevant overall financial limit.
- (v) Approving Authority includes authority for all documents necessary to implement the authority, on terms and conditions satisfactory to the Approving Authority, in consultation with the relevant operating Division(s).
- (w) Staff positions referred to in this delegation include successors from time to time.
- (x) Documents are to be in a form satisfactory to the City Solicitor (including indemnity and insurance provisions).
- (y) Delegated signing authorities in **B** are conditional upon the documents having received the City Solicitor’s prior “Approval as to Form”.
- (z) This delegation does not affect sales, acquisitions and leases over which the Affordable Housing Committee has responsibility.
- (aa) Authority to use land acquired by the City for parking purposes by the Toronto Parking Authority is conditional upon Council enacting a by-law designating such use.
- (bb) All residential leasing documents shall adhere to the *Residential Tenancies Act* and any successor legislation.
- (cc) Despite GC(n), Approving Authority in residential leasing matters is not limited to periods of less than twenty-one (21) years.

### SITE MAP

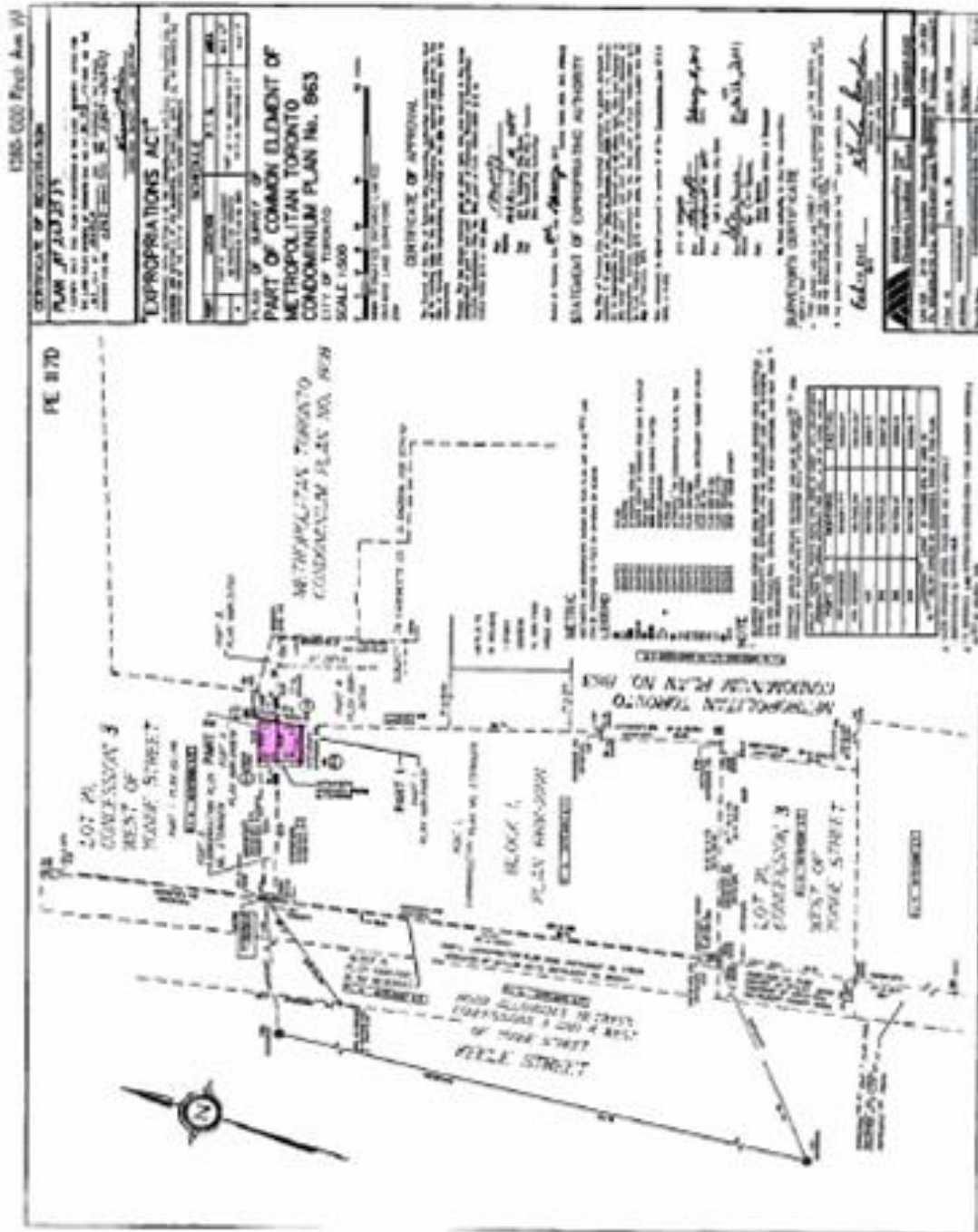
1280-1300 and 1290 Finch Avenue West
