Any notes of a mediation made by a member shall remain confidential and shall not be released to any person or admitted into evidence in any proceeding. Disclosure of the settlement terms and conditions that are proposed for approval by the Toronto Local Appeal Body may be disclosed. This does not affect the obligations of parties to make disclosure as otherwise required by the Rules.

If you do not attend the mediation, the Toronto Local Appeal Body may proceed with mediation and make a decision in your absence, and may authorize changes to the proposal, matter, or relief requested.
