**TORONTO LICENSING TRIBUNAL: March 22, 2017**  
**Summary of Decisions**

- 1. Frank Fortese** (Report No. 6769)  
Applicant for a Tow Truck Driver's Licence (Application No. B684929)

**DECISION:**

The Tribunal approved the following jointly Proposed Resolution:

A tow truck driver's licence will be issued to Frank Fortese, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of two (2) years to commence on March 22, 2017;
- (3) Prior to each of the next two (2) renewals of the licence, Mr. Fortese must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Fortese, those matters and report No. 6769, and any updating material, may be brought back before the Tribunal for a full hearing.

**DECISION:**

The Tribunal approved the following jointly Proposed Resolution:

A refreshment vehicle driver's licence will be issued to Arulananthan Kandasamy, effective immediately; and a motorized refreshment vehicle owner's licence will be issued to 2515750 Ontario Inc., effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Immediately upon being issued, the licences will be suspended for a period of five (5) days to commence on March 22, 2017;
- (3) Before the licences are reinstated, Mr. Kandasamy must provide to Municipal Licensing and Standards proof of payment of any overdue by-law fines against him or 7161905 Canada Inc.

**3. Imtiaz Ahmed** (Report No. 6789)

The Tribunal adjourned this matter to June 1, 2017.

**4. Muhammad Nadeem Mughal** (Report No. 6326)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3475561

**DECISION:**

The Tribunal approved the following jointly Proposed Resolution, **with amendment:**

Muhammad Nadeem Mughal's taxicab driver's licence will be renewed, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 60 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on March 22, 2017;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Mughal must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Mughal, those matters and report No. 6326, and any updating material, may be brought back before the Tribunal for a full hearing.

- (2) Mr. Freed undertakes not to drive a taxicab until the criminal charge is completed in court and the matter comes back before the Toronto Licensing Tribunal for a hearing.

- (2) Immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on March 22, 2017;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Penney must provide to Municipal Licensing and Standards, at his own expense, original up-to-date abstracts of his criminal record and driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Penney, those matters and report No. 6749, and any updating material, may be brought back before the Tribunal for a full hearing.

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Before the vehicle-for-hire licence is issued, Mr. Daramola must show proof of the reinstatement of his provincial driver's licence to Municipal Licensing and Standards.
- (3) Immediately upon being issued, the licence will be placed on probation for a period of two (2) years to commence on March 22, 2017;
- (4) Prior to each of the next two (2) renewals of the licence, Mr. Daramola must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Daramola, those matters and report No. 6740, and any updating material, may be brought back before the Tribunal for a full hearing.
