# TORONTO LICENSING TRIBUNAL: March 30, 2017 Summary of Decisions A.N. Alibhai / M. Calderwood / M. Laverty

# 1. Estate of Anne Sauve (Report No. 6869)

Robert Gary Sauve, Estate Trustee Holder of Taxicab Owner's Licence No. V02-4646928 for Taxicab Plate No. 1574

### DECISION:

The Tribunal extended taxicab owner's licence No. V02-4646928 for taxicab plate No. 1574 in the Estate of Anne Sauve for a period of three (3) months to June 30, 2017.

## 2. Abdulhossin Mazarei-Ghiri (Report No. 6735)

Applicant for a Vehicle-For-Hire Licence (Application No. B675619) AND

Applicant for a Taxicab Owner's Licence (Application No. B682532) for Taxicab Plate No. 1574

### **DECISION:**

A vehicle-for-hire licence will be issued to Abdulhossin Mazarei-Ghiri, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Immediately upon being issued, the licence will be placed on probation for a period of two (2) years to commence on March 30, 2017;
- (3) Prior to each of the next two (2) renewals of the licence, Mr. Mazarei-Ghiri must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Mazarei-Ghiri, those matters and report No. 6735, and any updating material, may be brought back before the Tribunal for a full hearing.

### **DECISION:**

### 5. The Eastmall Mart Inc. (Report No. 6757)

o/a The Eastmall Mart Mohammad Ahmed Toor, President Applicant for Renewal of Retail Store (Food) Licence No. B50-3250821

### **DECISION:**

The Tribunal approved the following jointly Proposed Resolution:

Mohammad Ahmed Toor's retail store (food) licence will be renewed, effective immediately, subject to the following conditions:

- Mr. Toor will, no later than April 21, 2017, hire an employee to immediately assist him in the operation of his retail store, located at 362 The East Mall (the "Store"), for the period ending on September 29, 2017;
- (2) This employee will be present in the Store at all times during hours of operation and will be solely responsible for interacting with customers except for the purchase of lottery tickets, which Mr. Toor will continue to oversee;
- (3) While Mr. Toor may be present at the Store, he will not directly interact with customers throughout the period ending on September 29, 2017

except for the above-noted purpose of lottery ticket sales;

- (4) Immediately upon being renewed, the licence will be placed on probation for a period of four (4) years to commence on March 30, 2017;
- (5) Prior to each of the four (4) renewals of the licence, Mr. Toor must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his criminal record; and
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6757, and any updating material, shall be brought back before the Tribunal for a full hearing.
- 6. Uyen Phan Trieu (Report No. 6672) Applicant for an Entertainer's Licence (Application No. B654574)

#### **DECISION:**

The Tribunal deemed Uyen Phan Trieu's application (No. B654574) for an entertainer's licence as abandoned.
