TORONTO LICENSING TRIBUNAL: January 29, 2015 Summary of Decisions D. Peacock / M. Calderwood / T. Yao

1. Waqas Ali (Report No. 6319) Applicant for a Taxicab Driver's Licence (Application No. B426492)

DECISION:

Waqas Ali's licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on January 29, 2015;
- (2) prior to each of the next three renewals of the licence, Mr. Ali must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of driving record;
- (3) during the probationary period, if Mr. Ali incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:

2. Iraj Shafiepour-Korraie (Report No. 6236) Holder of Taxicab Driver's Licence No. D01-0201077; Drivers' List No. 4429

DECISION:

The Tribunal deemed the employment service of Mr. Iraj Shafiepour-Korraie as having been uninterrupted.

3. Jamal Christian Steele (Report No. 6324) Applicant for a Tow Truck Driver's Licence (Application No. B429534)
