TORONTO LICENSING TRIBUNAL: September 3, 2015 Summary of Decisions T. Yao / M. Calderwood / L. Lampert

 The Tea Emporium Inc. (Report No. 6353) o/a The Tea Emporium Shabnam Weber, President Applicant for Retail Store Licences (Application Nos. B422226, B422228, B422229 and B422231)

DECISION:

The Tribunal approved the following jointly proposed resolution:

The Tea Emporium's licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of four (4) years to commence on September 3, 2015;
- (2) during the probationary period, if The Tea Emporium and Ms. Weber incur any new charges or convictions under the *Toronto Municipal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include their ML&S licence number and the ticket(s) number. Ms. Weber can notify Municipal Licensing and Standards in one of the following ways:

 Thiruchelvan Dharumachanthiran (Report No. 6413) Holder of Taxicab Driver's Licence No. D01-2902441 Applicant for a Taxicab Owner's Licence, Plate No. 4212 (Application No. B426755)

DECISION:

The Tribunal approved the following jointly proposed resolution:

Municipal Licensing and Standards, Licensing Services, will transfer over the conditions from the renewal of taxicab driver's licence No. D01-2902441, previously imposed by the Toronto Licensing Tribunal on April 25, 2013 and due to expire on February 1, 2016, to the new taxicab owner's licence.

Thiruchelvan Dharumachanthiran's taxicab owner's licence will be granted, effective immediately, subject to the following conditions:

- (1) Mr. Dharumachanthiran must provide to Municipal Licensing and Standards proof of payment of all or any outstanding fines;
- (2) The licence will be suspended for five (5) days;
- (3) immediately upon being reinstated, the licence will be placed on probation for a period of three (3) years;
- (4) prior to each of the next three renewals of the licence, Mr. Dharumachanthiran must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving and criminal records;
- (5) during the probationary period, if Mr. Dharumachanthiran incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, the must notify Municipal Licensing and Standards, in writing, within three (3) business days;
- (6) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6413, and any updating material, shall be brought back before the Tribunal for a full hearing; and
- (7) in addition, the notification shall include his ML&S licence number and the ticket(s) number. Mr. Dharumachanthiran can notify Municipal Licensing and Standards in one of the following ways:

DECISION:

The Tribunal approved the following jointly proposed resolution, **as amended**:

Adeshina Ademoy Keshinro's taxicab driver's licence will be renewed, effective immediately, subject to the following conditions:

- immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on September 3, 2015;
- (2) prior to each of the next three renewals of the licence, Mr. Keshinro must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his driving and criminal records;
- (3) during the probationary period, if Mr. Keshinro incurs any new charges or convictions under the *Toronto Municipal Code*, the *Criminal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket(s) number. Mr. Keshinro can notify Municipal Licensing and Standards in one of the following ways:

- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6386, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered the following three amendments to the original Proposed Resolution as follows:

- *i.* Condition (1) regarding licence suspension is to be removed.
- ii. Condition (2) regarding outstanding fines is to be removed.
- *iii.* Bolded paragraph on page 2 regarding outstanding by-law fines is to be removed.

DECISION:

The Tribunal approved the following jointly proposed resolution, **as amended**:

Crown Ways Limousine Inc.'s limousine service company provider's and limousine owner's licences will have the following conditions imposed, effective immediately:

- (1) the licences shall be immediately suspended for a period of three (3) days, to commence on Tuesday, September 8, 2015; and Mohammad Daniyal, Mohamed Arshad, Akram Tahir or Sajid Mahmood must surrender the limousine service company provider's and limousine owner's licences and photo cards on that date:
- (2) Mohammad Daniyal, Mohamed Arshad, Akram Tahir and Sajid Mahmood must provide to Municipal Licensing and Standards proof of payment of any outstanding by-law fines before the date of the hearing, failing which the licence will be suspended until proof of payment of any outstanding fines is filed;
- (3) the licence will be placed on probation for a period of two (2) years, to commence on September 3, 2015;
- (4) prior to each of the next two renewals of the licence, Mohammad Daniyal, Mohamed Arshad, Akram Tahir and Sajid Mahmood, must provide to Municipal Licensing and Standards, at their own expense, updated abstracts of driving records of each of the 4 Directors of Crown Way (being Messrs. Daniyal, Arshad, Tahir and Mahmood);
- (5) during the probationary period, if Crown Ways Limousine Inc. or Mohammad Daniyal, Mohamed Arshad, Akram Tahir and Sajid Mahmood incur any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, Mohammad Daniyal, Mohamed Arshad, Akram Tahir and Sajid Mahmood must notify Municipal Licensing and Standards, in writing, within three (3) business days of receipt of the ticket(s). The notification shall include their ML&S licence number and the ticket(s) number. Mohammad Daniyal, Mohamed Arshad, Akram Tahir and Sajid Mahmood can notify

Municipal Licensing and Standards in one of the following ways:

DECISION:

The Tribunal extended taxicab owner's licence Nos. V02-4428463 and V02-4428465 for taxicab plate Nos. 2370 and 2399 in the Estate of Margaret A. Rondeau for 9 (nine) months.

6. Dimitris Katsaounis (Report No. 5697) Holder of Refreshment Vehicle Driver's Licence No. D13-3122112

DECISION:

The Tribunal revoked Dimitris Katsaounis' refreshment vehicle driver's licence No. D13-2122112.

7. Jeyakumar Balasubramaniam (Report No. 6387) Holder of Taxicab Driver's Licence No. D01-4296858

DECISION:

Jeyakumar Balasubramaniam's taxicab driver's licence will have the following conditions imposed, effective immediately:

- (1) the licence will be placed on probation for a period of two (2) years to commence on September 3, 2015;
- (2) prior to each of the next two renewals of the licence, Mr. Balasubramaniam must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;

9. Rotana Inc. (Report No. 6421)

o/a Cloud 9 Café Hussein Souddo, Managing Director Applicant for an Eating Establishment Licence (Application No. B5368978)

DECISION:

Rotana Inc. will be issued an eating establishment licence with the following conditions imposed on it, effective immediately:

- (1) The licence will be placed on probation for a period of three (3) years to commence on September 3, 2015;
- (2) during the probationary period, Rotana Inc. and its officers must ensure that the conduct of patrons in the interior or on the immediate exterior of 1530 Danforth Avenue is monitored on an ongoing basis during the operating hours of the establishment;
- (3) during the probationary period, Rotana Inc. and its officers must ensure that all necessary steps are taken to prevent and to immediately address unruly conduct of any patron of the establishment, including but not limited to any patron who appears under the influence of alcohol or any other illicit substance;
- (4) prior to each of the next three (3) renewals of the licence, the Managing Director of Rotana Inc., Hussein Souddo, must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his criminal record;
- (5) during the probationary period, if Rotana Inc., or any of its officers, incur any new charges under Chapter 545 issued by the Toronto Police Service, or any charges or convictions under the *Criminal Record of Canada*, or any charges under any other City of Toronto bylaw, Hussein Souddo must notify Municipal Licensing and Standards, in writing, within three (3) business days, which can be done in the following ways:
