1. S. N. (Report No. 6216)

Applicant for a Taxicab Driver's Licence (Application No. B315715)

DECISION:

The Tribunal adjourned this matter sine die pending the availability of counsel and witnesses.

2. Christopher James Casella (Report No. 6444)

Applicant for a Tow Truck Driver's Licence (Application No. B537380)

DECISION:

Christopher James Casella withdrew his application (No. B537380) for a tow truck driver's licence.

3. Estate of Sandor Weisz (Report No. 6500)

Ernest Andrew Weisz, Estate Trustee Holder of Taxicab Owner's Licence Nos. V02-4316204 and V02-4316206 for Taxicab Plate Nos. 1152 and 3203

DECISION:

The Tribunal extended taxicab owner's licence Nos. V02-4316204 and V02-4316205 for taxicab plate Nos. 1152 and 3203 in the Estate of Sandor Weisz until March 31, 2016, with the following conditions:

- (1) Plate Nos. 1152 and 3203 to be remitted to Municipal Licensing and Standards by Tuesday, November 10, 2015;
- (2) Plate Nos. 1152 and 3203 not to be terminated but held in abeyance by Municipal Licensing and Standards until sale is complete;
- (3) Municipal Licensing and Services reserves the right to change its

- (4) The Estate of Sandor Weisz is ordered to remit the outstanding renewal fees for both plates by January 11, 2016;
- (5) The Estate must submit the following outstanding documentation to Municipal Licensing and Standards:

- Previous plates or current plates
- Certificate of Insurance
- Vehicle inspection
- Used Vehicle package from the Ministry of Transportation
- Invoice for vendor
- (6) The Estate of Sandor Weisz must provide a Certificate of Appointment of Estate Trustee;
- (7) All documents must be submitted no later than minimum 5 days before the March 31, 2016 Tribunal hearing.
