1. 2332980 Ontario Inc. (Report No. 6278)

Holder of Body Rub Parlour Owner's Licence No. B38-4201082

DECISION:

The Tribunal approved the following jointly proposed resolution:

2332980 Ontario Inc.'s body rub parlour owner's licence shall be renewed, effective immediately, subject to the following conditions:

- (1) The licence shall be suspended as of November 26, 2015 for a period of seven (7) days, and the business shall remain closed to the public during this period;
- (2) The applicant shall be placed on probation for a period of three (3) years as of November 19, 2015 (the "Probation Period");
- (3) Prior to each of the next three renewals, the applicant shall provide to Municipal Licensing and Standards ("MLS"), at its own expense, an updated abstract of Serena Yuk Yu Li's criminal record (provided that she remains the Designated Manager or otherwise employed by the applicant);
- (4) During the probationary period, the applicant shall notify Municipal Licensing and Standards, in writing, within three business days, of any charges or convictions incurred by either the applicant or Serena Yuk Yu Li (provided that she remains the Designated Manager or otherwise employed by the applicant) under the *Criminal Code* or the *Toronto Municipal Code* in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (5) any such charges or convictions incurred during the probationary period which are of concern to Municipal Licensing and Standards may

be brought forward, along with the report, for a hearing before the Toronto Licensing Tribunal; and

- (6) the Notice of Constitutional Question filed by the applicant in this case shall be withdrawn immediately.

DECISION:

3. Khalid Panjshiri (Report No. 6383)

Applicant for a Taxicab Driver's Licence (Application No. B428695)

DECISION:

The Tribunal approved the following jointly proposed resolution:

Khalid Panjshiri's taxicab driver's licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on November 19, 2015;
- (2) during the probationary period, if Mr. Panjshiri incurs any new charges or convictions under *Toronto Municipal Code* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Panjshiri can notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (3) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6383, and any updating material, shall be brought back before the Tribunal for a full hearing.
