Purpose:	To declare surplus two portions of Dundas Street West located adjacent to 3819 Bloor Street West and shown as Parts 1 & 2 on Sketch No. PS-2016-082, conditional upon City Council approving the permanent closure of these portions of Dundas Street West as a public highway, and to authorize the invitation of an offer to purchase Parts 1 & 2 on Sketch No. PS-2016-082 from the owner of 3819 Bloor Street West, which includes a land exchange that will result in certain portions of 3819 Bloor Street West being conveyed to the City, to facilitate the completion of the Six Points Interchange Reconfiguration Project.												
Property:	Two portions of Dundas Street West located along the southern and eastern property boundary of 3819 Bloor Street West, shown as Parts 1 & 2 on Sketch No. PS-2016-082 attached as Appendix "A" (the "Property").												
Actions:	<ol style="list-style-type: none"> 1. The Property be declared surplus, conditional upon City Council approving the permanent closure of the Property as a public highway, and an offer to purchase the Property be invited from the owner of 3819 Bloor Street West, which includes a land exchange that will result in certain portions of 3819 Bloor Street West being conveyed to the City. 2. Notice be published in a newspaper in circulation in the area of the Property and on the City's website. 3. All steps necessary to comply with the City's real estate disposal process, as set out in Chapter 213 of the City of Toronto Municipal Code, be taken. 												
Financial Impact:	<p>There are no financial implications resulting from this approval.</p> <p>The Deputy City Manager & Chief Financial Officer has reviewed this DAF and agrees with the financial impact information.</p>												
Background:	<p>The Property was not acquired through expropriation proceedings. Parts 1 and 2 of Sketch No. PS-2016-082 (part of the public highway lands along Dundas Street West) were reverted to former Metro by Order in Council 2806/62 (EB263000).</p> <p>As part of the City-initiated Six Points Interchange Reconfiguration Project, the owner of 3819 Bloor Street West was approached by City staff and has agreed (in principle) to a proposed land exchange. The proposal would involve the City's sale of the Property to the property owner in exchange for equal-sized lands located on the north-east corner of 3819 Bloor Street West (to create a new turning lane along Bloor Street West onto Kipling Avenue).</p> <p>Transportation Services has completed its circulation process and review of the Property and has no objections to the closure of this part of Dundas Street West.</p>												
Comments:	A circulation to the City's ABCDs was undertaken to ascertain whether or not there is any municipal interest in retaining the Property. No municipal interest was expressed. Staff of the Affordable Housing Office has determined that there is no interest in the Property for affordable housing. Accordingly, it is appropriate that the Property be declared surplus. The Property Management Committee has reviewed this matter and concurs.

Pre-Conditions to Approval:

- (1) **Highways** - The GM of Transportation Services has concurred in the Highway being declared surplus conditional upon City Council approving the permanent closure of the Highway.
- (2) **Lands located within the Green Space System and the Parks & Open Space Areas of the Official Plan** - The Chief Planner & Executive Director and the GM of Parks, Forestry & Recreation have confirmed that the land being exchanged is (i) nearby land of equivalent or larger area, and (ii) of comparable or superior green space utility.

Chief Corporate Officer has approval authority for:

- A (1) declaring land surplus and approving the intended manner or process by which the sale of the land will be carried out, provided that the local Councillor does not require the matter to be determined by Council through the Government Management Committee (§ 213-6).
 - Councillor does not require the declaration of surplus or the intended manner or process by which the sale of the land will be carried out to be determined by Council.
- (2) determining the method of giving notice to the public, following consultation with the local Councillor (§ 213-7)
 - Councillor has been consulted regarding method of giving notice to the public.
- (3) exempting sales to the following public bodies from the requirement for an appraisal, provided that the local Councillor (or if the land abuts other wards, the local Councillors) does not require the determination to be made by Council (§ 213-4):
 - (a) a municipality
 - (b) a local board, including a school board and a conservation authority
 - (c) the Crown in right of Ontario or Canada and their agencies
 - n/a Councillor(s) agrees with exemption from appraisal.
- (4) exempting the sale of land in the following classes from the requirement for an appraisal and/or for notice to the public, provided that the local Councillor(s) (if the land abuts other wards) does not require the determination to be made by Council (§ 213-5):
 - (a) land 0.3 metres or less in width acquired in connection with an approval or decision under the *Planning Act*
 - (b) closed highways if sold to an owner of land abutting the closed highways
 - (c) land formerly used for railway lines if sold to an owner of land abutting the former railway land
 - (d) land does not have direct access to a highway if sold to the owner of land abutting that land
 - (e) land repurchased by an owner in accordance with section 42 of the *Expropriations Act*
 - (f) easements
 - n/a Councillor(s) agrees with exemption from appraisal.
 - n/a Councillor(s) agrees with exemption from notice to the public.
- (5) revising the intended manner of sale
- (6) rescinding the declaration of surplus authority

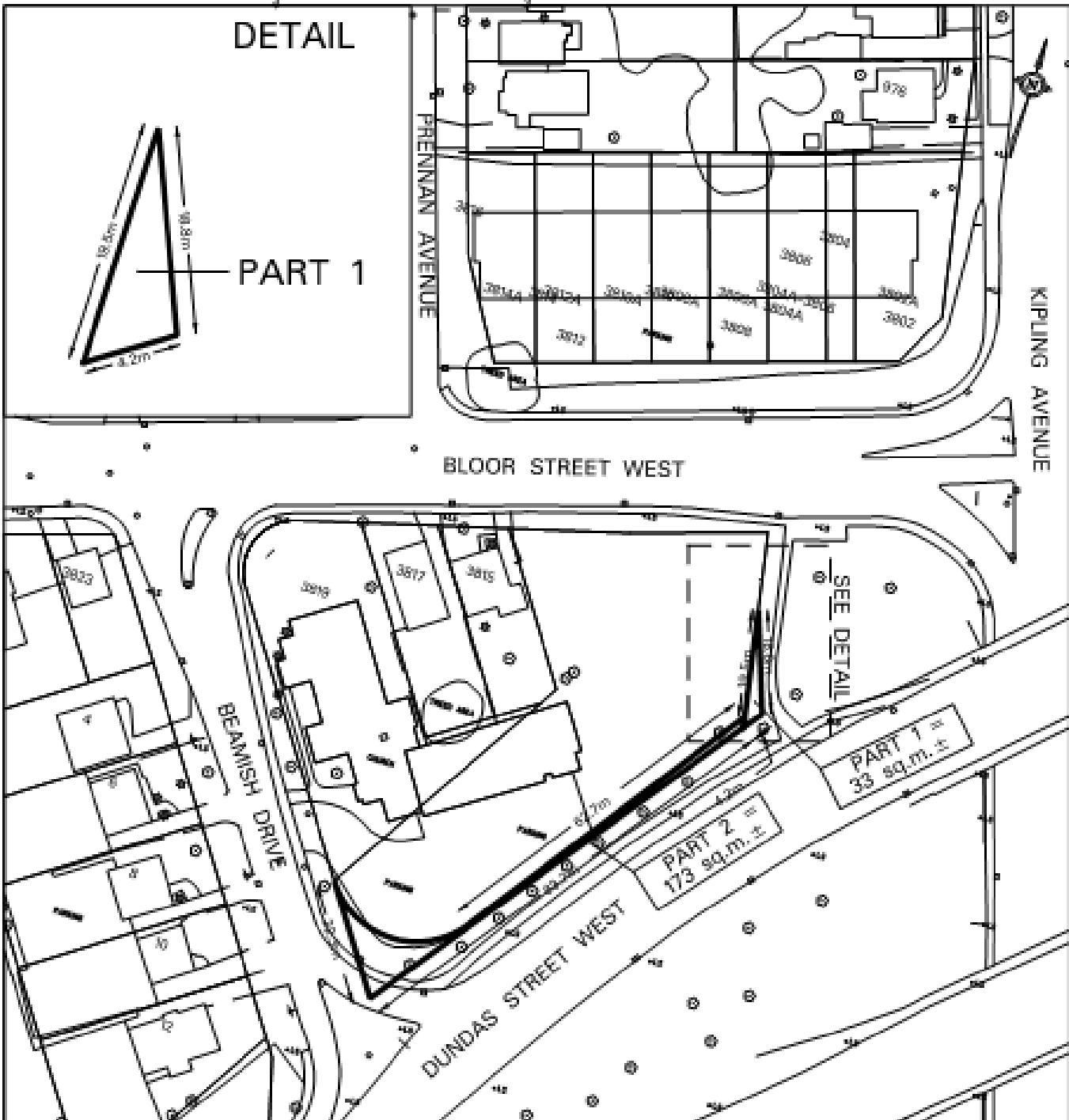
