TORONTO LICENSING TRIBUNAL: October 15, 2015 Summary of Decisions N. Treksler / A. Alibhai / A. Walsh

1. Gregory Chad Brnjosevic (Report No. 6414) o/a Cool Breeze Ice Cream

Applicant for a Motorized Refreshment Vehicle Owner Licence for Motorized Refreshment Vehicle Plate No. 1230 (Application No. B427371)

DECISION:

The Tribunal approved the following joint submission:

Gregory Chad Brnjosevic's licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being issued, the licence will be placed on probation for a period of four (4) years to commence on October 15, 2015;
