
TORONTO LICENSING TRIBUNAL: July 16, 2015
Summary of Decisions

- 1. Zafar Iqbal** (Report No. 6180)
Holder of Taxicab Driver's Licence No. D01-3606780

DECISION:

Zafar Iqbal's taxicab driver's licence will be renewed subject to the following conditions:

- (1) If Mr. Iqbal renews his taxicab driver's licence for the period June 5, 2015 to June 5, 2016, the licence shall be immediately suspended for a period of twenty (20) days; and the licensee must surrender his licence and photo card on that date. Failure to do so will result in revocation of the licence;
- (2) Mr. Iqbal must provide to Municipal Licensing and Standards proof of payment of any outstanding renewal fees;
- (3) upon renewal, the licence will be placed on probation for a period of three (3) years;
- (4) prior to each of the next three renewals of the licence, Mr. Iqbal must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record and criminal record;
- (5) during the probationary period, if Mr. Iqbal incurs any new charges or convictions under the *Toronto Municipal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket(s) number. Mr. Iqbal can notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (6) within the next six (6) months, starting from July 16, 2015, Mr. Iqbal must attend, at his own expense, the following four training modules:

July 16, 2015

- I. Disability Awareness
- II. Accessibility for Ontarians with Disability
- III. Passenger Assistance
- IV. Human Rights and Cultural Diversity

(7) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, or if Mr. Iqbal fails to take the training modules, those matters and report No. 6180, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Municipal Licensing and Standards, Licensing Services, to send a letter to Mr. Iqbal advising him of the outcome of today's proceedings.

(Mr. Iqbal failed to attend today's hearing).

Applicant for Renewal of Taxicab Driver's Licence No. D01-3597849
Applicant for a Limousine Driver's Licence (Application No. B538901)

DECISION:

The Tribunal approved the following joint resolution:

Getu Kifle Assefa's taxicab driver's licence will be renewed, and his application for a limousine driver's licence will be granted, effective immediately, subject to the following conditions:

- (1) Mr. Assefa must provide to Municipal Licensing and Standards proof of payment of all outstanding renewal fees;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of four (4) years to commence on July 16, 2015;

- (3) prior to each of the next four renewals of the licence, Mr. Assefa must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;

Applicant for a Tow Truck Driver's Licence (Application No. B532741)

DECISION:

John Adelino Dias Gomes' licence will be issued, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on July 16, 2015;
- (2) prior to each of the next three renewals of the licence, Mr. Gomes must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record and criminal record;
