### **DECISION:**

The Tribunal approved the following jointly proposed resolution, as amended:

Zameer Abbas' application for a limousine driver's licence will be issued, and both his taxicab driver's licence and limousine driver's licence will have the following conditions imposed, effective immediately:

- (1) the licences shall be immediately suspended for a period of twenty-one (21) days to commence on June 25, 2015; and the licensee must surrender his taxicab driver's licence and photo card on that date;
- (2) the licences will be placed on probation for a period of four (4) years to commence on June 25, 2015;
- (3) prior to each of the next four renewals of the licences, Mr. Abbas must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record:
- (4) during the probationary period, if Mr. Abbas incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:
  - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via email to mlsconditionreporting@toronto.ca; or
  - via fax at 416-392-3102

(5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6280, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Zameer Abbas to surrender his photo card and licence to Municipal Licensing and Standards immediately.

The Tribunal further ordered the following amendment to the original Proposed Resolution as follows:
