# TORONTO LICENSING TRIBUNAL: June 4, 2015 Summary of Decisions L. Miskin / M. Calderwood / T. Yao

## **DECISION:**

This matter was dealt with at the May 28, 2015 Tribunal hearing.

2. Shishai Tekle (Report No. 6270)

o/a Mega City Driving School Applicant for Renewal of Driving School Instructor's Licence No. V11-3722568; Driving School Plate No. 4855

#### **DECISION:**

The Tribunal approved the following joint resolution:

Shishai Tekle's driving school instructor's licence will be renewed, effective immediately, subject to the following conditions:

- (1) the licence shall be immediately suspended for a period of five (5) days to commence on June 4, 2015 and ending June 8, 2015;
- (2) the licence will be placed on probation for a period of four (4) years to commence on June 4, 2015;
- (3) prior to each of the next four renewals of the licence, Mr. Tekle must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Tekle incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:

- - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via email to mlsconditionreporting@toronto.ca; or
  - via fax at 416-392-3102
  - (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6270, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Shishai Tekle to surrender his licence and photo card to Municipal Licensing and Standards immediately.

**3. Getu Kifle Assefa** (Report No. 6185) Applicant for Renewal of Taxicab Driver's Licence No. D01-3597849

The Tribunal approved the following jointly proposed resolution:
