TORONTO LICENSING TRIBUNAL: April 16, 2015 Summary of Decisions T. Yao / L. Lampert / D. Peacock

1. Belal Mohamed Ahmed (Report No. 6177)

Applicant for Renewal of Taxicab owner's Licence No. V02-3114506, Accessible Taxicab Plate No. W0001

AND

Applicant for Taxicab Owner's Licence (Application No. B424541)

DECISION:

The Tribunal approved the following joint settlement:

Belal Mohamed Ahmed's taxicab owner's licence will be issued, effective immediately, subject to the following conditions:

- the licence will be suspended until it is sold, where upon the purchaser may have issued to him/her a fresh Toronto taxicab licence, free of suspension;
- (2) Mr. Ahmad must pay for all fees associated with the taxicab owner's licence;
- (3) on October 15, 2015, or at any time before, if desired by either the City or Mr. Ahmed, a hearing will be convened to alter the terms of the licence;
- (4) the April 16, 2015 panel is not seized for the October 15, 2015 Tribunal hearing or any earlier hearing;
- (5) Mr. Ahmed must surrender his taxicab owner's plate, photo card and I.D. forthwith.

2. Estate of Peter Skleryk (Report No. 6371)

DECISION:

The Tribunal extended taxicab owner's licence No. V02-4314908 for taxicab plate No. 2849 in the Estate of Peter Skleryk to July 7, 2015.

3. Sheraz Hussain (Report No. 6235)

Applicant for Renewal of Taxicab Driver's Licence No. D01-4073162

DECISION:

The Tribunal approved the following jointly proposed resolution:

Mr. Hussain's taxicab driver's licence will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of two (2) years to commence on April 16, 2015;
- (2) prior to each of the next two renewals of the licence, Mr. Hussain must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Hussain incurs any new charges or convictions under the *Toronto Municipal Code*, or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:

- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and [report No. 6235, and any updating material, shall be brought back before the Tribunal for a full hearing.

4. Safdar Zaidi (Report No. 6225)

Holder of Taxicab Driver's Licence No. D01-4292052

DECISION:

The Tribunal approved the following jointly proposed resolution:

Mr. Zaidi's taxicab driver's licence will have the following conditions imposed, effective immediately:

- (1) the licence will be immediately suspended for a period of five (5) days to commence on April 16, 2015 and the licensee must surrender his taxicab driver's licence and photo card on April 16, 2015;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on April 16, 2015;
- (3) prior to each of the next three renewals of the licence, Mr. Zaidi must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Zaidi incurs any new charges or convictions under the *Toronto Municipal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to: mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (5) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6225, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Zaidi to surrender his licence and photo card to Municipal Licensing and Standards today and advised that he can pick up his documents on Tuesday, April 21, 2015.

5. Amanuel B. Zewengel (Report No. 6254)

Applicant for Renewal of Taxicab Owner's Licence No. V02-3476396 for Ambassador Taxicab Plate No. A1006

DECISION:

The Tribunal renewed Amanuel B. Zewengel's Ambassador taxicab owner's licence, without conditions.

6. Navdeep Bajwa (Report No. 6277)

Holder of Taxicab Owner's Licence No. V02-4308094 for Taxicab Plate No. 1384

DECISION:

The Tribunal transferred the conditions previously placed on Navdeep Bajwa's taxicab driver's licence on March 21, 2013 to his taxicab owner's licence, effective immediately to March 21, 2017.

- (1) immediately upon being issued, the licence will be placed on probation until March 21, 2017;
- (2) every six months, Mr. Bajwa shall provide to Municipal Licensing and Standards, at his own expense, an updated driver's abstract;
- (3) during the probationary period, if Mr. Bajwa incurs any charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 5922, and any updating material, shall be brought back before the Tribunal for a full hearing.

7. Morgan Otuo Acheampong (Report No. 6271)

Holder of Taxicab Driver's Licence No. D01-3121821

DECISION:

The Tribunal adjourned this matter to May 4, 2015.
