

Info Sheet #2: What Guides this Study?

Provincial policy guides growth and development in the province of Ontario. The **Provincial Policy Statement** and the **Growth Plan for the Greater Golden Horseshoe** (the 'Growth Plan') are two documents that set out where and how to grow. The Growth Plan encourages increased residential and employment growth around rapid transit stations which will soon be in operation at Don Mills and Eglinton (Science Centre Station). But it also requires this growth to provide an appropriate range and mix of uses and factor the provision of community infrastructure. Municipalities are required to identify areas to be protected for employment, which the City of Toronto has recently completed done by identifying 'employment areas' to the north of Eglinton Avenue East. This protection of employment areas means that there will be no consideration of future residential uses on these lands through the Don Mills Crossing Study on areas designated *Employment Areas* in the City's Official Plan.

Metrolinx, which is a regional body responsible for planning and operating transit lines throughout the Greater Golden Horseshoe, created a document called '**The Big Move**'. The Big Move is a Regional Transportation Plan and identifies areas called 'Mobility Hubs'. Don Mills and Eglinton is a Mobility Hub, defined as an area 800 metres around two or more rapid transit lines with an anticipated minimum future transit trips. These areas are encouraged to accommodate more jobs and residents in order to support the investment in transit and the efficient operation of the transit lines. To assist municipalities in studying and planning Mobility Hubs, Metrolinx created **Mobility Hub Guidelines** which provides guidance on creating study boundaries and target densities, as examples.

- A strong and competitive economy with a vital downtown that creates and sustains well-paid, stable, safe and fulfilling employment opportunities for all;
- Clean air, land and water;

- A wealth of recreational opportunities that promote health and wellness;
- A spectacular waterfront that is diverse and beautiful;
- Cultural facilities that celebrate the best of city living; and
- Beautiful architecture and excellent urban design that astonish and inspire.
