The public meeting was attended by close to 200 members of the Guildwood community including representatives from various community associations such as the Guildwood Village Community Association, Guild Renaissance Group, Friends of Guild Park, and the Guild Festival Theatre. The consultation event ran smoothly. Participants were actively engaged in discussions at the breakout tables, following presentations. Positive comments about the process were received by City staff and the consultation team members.

MEETING SUMMARY:

- 1. Councillor Paul Ainslie welcomed attendees and provided a brief description of the need for a management plan for Guildwood Park to help coordinate a range of city and TRCA initiatives.
- 2. Introductions were made by Ruthanne Henry.
- 3. David Leinster welcomed attendees and described the special place of Guildwood Park in the City's park system.
- 4. Joanna Swietlik gave a presentation about the proposed revitalization development for Guild Inn by Dynamic.
- 5. Ray Kessler provided a summary of the city's Cultural Precinct Plan for Guild Park.
- 6. Nancy Chater gave a presentation about the landscape management plan. The presentation is attached in pdf form with this report.
- 7. Donna Hinde facilitated the break-out discussion group process which was structured as follows:
 - 1. Participants moved from one table to the next in four twenty minute intervals and provided feedback on four key themes of the management plan. They also commented on the communications process with the City at a separate table. Feedback was collected at 15 discussion tables, each facilitated by a city staff member from various related departments. Each table also included a sheet to gather key words for a Vision Statement for Guild Park.
 - 2. There were three tables for each topic; Trails, Culture/heritage, Natural Heritage, Events, and Horticulture. Participants could also speak one-on-one to team members at the front and back of the room, where additional theme maps were located.
- 8. Donna Hinde closed the meeting with comments about the importance of hearing from all community members present and thanked people for speaking up in the small-group conversation format.
- 9. Councillor Ainslie thanked the group for attending.
- 10. MPP Mitzie Hunter spoke to the group and expressed her interest in community feedback about the park.

The feedback on the 4 themes, Events, Vision Key Words and Communications were collected and are summarized below, by theme and topic:

1. Natural Heritage Theme

- i. Importance of protecting natural heritage
 - 1. Vitally important for wildlife (repeated)
 - 2. "On a scale of 1 to 10 it's a 50"
 - 3. Forest is most important to protect for future
 - 4. Very important to protect native plants
 - 5. Important, but also important to have it safe and accessible while maintaining the integrity of the forest
- ii. Familiarity with EAB program
 - 1. Still too much debris most common complaint
 - 2. Most in support of it
 - a. Lots of concern remains
 - b. "Did you mean the near clear cutting of our precious forest?"
 - 3. Is new tree planting necessary?
 - 4. Plant big trees sassafrass, birch, fast growing species
 - 5. Some animals have disappeared since logging of the Ash trees
 - 6. Opportunity for replanting native species
- iii. Balance between woodland and horticulture
 - 1. Current balance is good (repeated)
 - 2. More manicured areas means more cost to maintain it
 - 3. No more gardens
 - 4. Concern with cutting more trees to create views
 - a. If you want to see views go to the edge of the bluffs
 - b. At the edge you want seclusion not view of development
 - 5. 2/3 natural 1/3 manicured is a good balance prefer natural
 - 6. Retain its character so that the children growing up in this neighbourhood, as well as the many visitors to come, will have a natural space to play and let their imaginations run wild

 - 2. There should be spurs off main trails to garden features
 - 3. Maintain existing E-W trails through the park
 - 4. Some of the informal forest trails should be closed
 - 5. There should be a formalized entrance at corner near Laurier track where students cut through the fence
 - 6. The north-south maintenance road near building 191 is ok
 - 7. Retain all existing pathways do not reduce in woodlot
- iv. What new trails should be added?
 - 1. Skate Trail
 - 2. Water shuttle from downtown?
 - 3. New informal trail just north of switch back trail should become the permanent waterfront access trail (could be a boardwalk)
 - 4. Access to the heritage features
 - 5. Trail connection to the waterfront
 - 6. Can the waterfront trail be connected to Bluffers of Bellamy ravine?
 - 7. Allow access from Livingston apartment buildings
 - 8. Access along Laurier fence line to clean up garbage

- vii. Fencing Participants were shown a number of fencing options including metal picket and wood split rail style fences and asked to comment on their preference:
 - 1. Reinstate the chain link fence along Guildwood Parkway
 - 2. Like that the fence is down along Guildwood Parkway (repeated)
 - 3. Remove fence along Guildwood Parkway (repeated) enhance the gardens as a barrier instead
 - 4. Use as little fencing along the trail as possible
 - 5. Add post and paddle fence along the bluffs
 - 6. Use aluminum fencing for visible areas
 - a. Aluminum fencing is preferable doesn't allow termites or carpenter ants
 - 7. Mark trails with post and paddle fencing no wire though
 - 8. Using fencing to manage dogs.
 - 9. Don't mark trails with fencing use soldier course, more signage, interpretive signs instead
 - 10. Stone fencing in key areas
 - 11. Fences are expensive 🛞
 - 12. No aluminum fencing too intrusive
 - 13. Minimal to no fencing fences send the wrong message along Guildwood Parkway, suggesting that the park is not an open, public space
- viii. Bluffs
 - 1. Viewing platform is important
 - a. Platform with benches like at Rouge Park

- b. Should be managed lookouts with raised trails (repeated)
- 2. Visitors from outside the community don't appreciate the risk of the bluffs. There should be more signage
- 3. Move trail back from edge of bluffs

- 5. Consolidate existing informal trails into formal trail with official lookouts
- ix. General Comments about Trails and facilities that could be related to trails:
 - 1. Parking should be screened from road!
 - 2. Winter access/clearing is costly for operators
 - 3. More drinks, snacks, garbage cans, recycling cans, drinking fountains, washrooms
 - 4. Add rest areas at key points along the trails (repeated)
 - 5. Create safe trails without making barriers; be aesthetic
 - 6. Use signage more than fences eg "please stay on the trail" with reasons
 - 7. Should be more benches (repeated)
 - a. Comfortable seating
 - b. Reuse stumps and wood from Ash to build benches and boardwalks
 - 8. Other trail hazards are mosquitos from May to Oct.
 - 9. A few water fountains would be good
 - 10. Construction staging area should be open for parking 3 seasons
 - 11. Careful not to remove any more trees when opening or closing trails
 - 12. Integration of trail connections to the community
 - 13. Consolidate trails where there are 3-4 trails make one good trail instead
 - 14. Opportunity for interpretive signage and wayfinding
 - 15. Need to plan trails so planting is not impacted
 - 16. Trail management is necessary to prevent trail width increase and deal with wet patches
 - 17. If closing trails use natural looking fences
 - 18. Need ways to designate and prioritize trails to allow multiple uses/needs
