
Intersection Improvements at Millwood Road and Laird Drive

Contract: 17ECS-TI-11MR
Expected Start Date: October 2, 2017
Expected End Date: November 30, 2017

*Timeline is subject to change.

The City of Toronto will improve the intersection at Millwood Road and Laird Drive. This work will involve replacing the eastbound right-turn channel with a right-turn lane. This is in order to address safety concerns and allow for the installation of audible pedestrian signals for the visually impaired, as required by the Accessibility for Ontarians with Disabilities Act. The TTC bus stop platform will be reconstructed to better serve new buses and improve green space at this intersection. This project is part of the Council-approved 2017 Capital Works Program.

WORK DETAILS

The City's contractor will:

- Replace eastbound to southbound right-turn channel with right-turn lane
- · Install traffic poles and signals
- · Build landscaping features and plant trees, etc.
- · Dig up and repave the road surface
- · Restore areas affected by construction

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and / or decorative objects. If you have a sprinkler system within the boulevard, please contact the Project Manager.
- The City will not be responsible for damage to any privately owned items on City property.



Construction Notice



Work Hours: Work will take place from 7:00 am to 11:00 pm., Monday to Friday, and from 9:00 am to 9:00 pm., Saturday and Sunday, with work after hours and on weekends as required and as approved by the City.



Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.

Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.



Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Some of these efforts include adding Local Access signs, revising traffic signal times. Road users should expect delays and increased traffic on nearby main and side streets.

Traffic on Millwood Road and Laird Drive will be reduced to one lane each direction in the vicinity of the intersection.



Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at **416-808-2222**.

In the event you receive a traffic ticket for on-street parking during this period of construction, you may choose to dispute your ticket at one of the locations listed on the reverse side of the parking infraction notice. You may use this notice as part of your defence for parking consideration during construction; however, the Project Manager does not have the authority to cancel any parking tickets.



TTC Service: This project may affect travel times on the 56 Laird Drive and 88 Millwood Road routes. Visit ttc.ca for accurate schedule information.



Garbage & Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. *Please ensure that you label your bins with your address.*



Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
