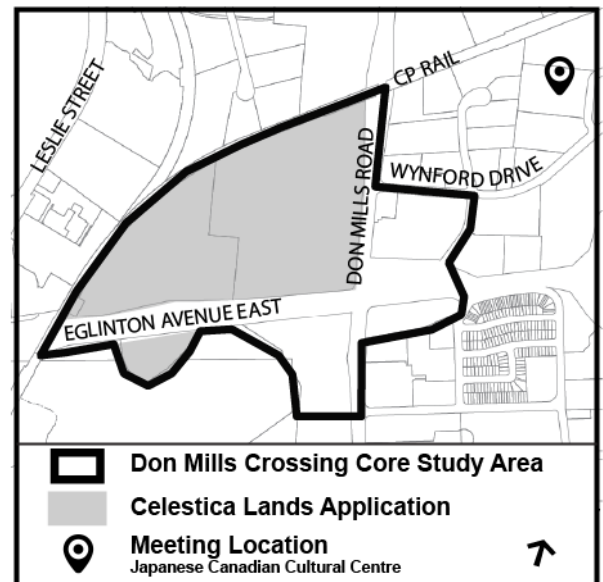
Don Mills Crossing / Celestica Lands Development Applications

Community Meeting and Open House

Join us on February 21st for a presentation and open house on the Don Mills Crossing study and the Celestica development applications. This is a key city building moment for Don Mills and Eglinton! **We want to hear from you!**

The City of Toronto's Don Mills Crossing is examining ways to focus and shape anticipated growth around Don Mills Road and Eglinton Avenue East.

The City is also reviewing development applications for 844 Don Mills Road, 1150 and 1155 Eglinton Avenue East (the "Celestica Lands") within the Core Study Area for Don Mills Crossing. The development applications propose a new mixed-use community of residential, office, commercial, retail and recreational uses along with new public streets and parks. The site's redevelopment is proposed over a number of phases.
