# TORONTO LICENSING TRIBUNAL: November 9, 2017 Summary of Decisions M. Calderwood / A. Walsh / A. Alibhai

1. Ahmed Hussen Ahmed (Report No. 6616) Holder of Taxicab Driver's Licence No. D01-3732650; Driver's List No. 6276

# **DECISION:**

The Tribunal deemed Mr. Ahmed Hussen Ahmed's driving service during the year 2014 to be uninterrupted.

2. Farid Ahmed Malik (Report No. 6817)

Applicant for Vehicle-For-Hire Driver's Licence (Application No. B709183) AND

Applicant for Renewal of Taxicab Owner's Licence No. V02-4075433

## **DECISION:**

The Tribunal approved the following Proposed Resolution:

- Taxicab Owner's Licence will be renewed without conditions.
- Vehicle-For-Hire Driver's licence will be issued subject to the following condtions:
- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application will be cancelled;
- (2) Immediately upon being issued, the licence will be suspended for a period of twenty-one (21) days;
- (3) Immediately upon being issued, the licence will be placed on probation for a period of two (2) years;
- (4) Prior to each of the next two (2) renewals of the licence, Mr. Malik must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record;

- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6817, and any updating material, shall be brought back before the Tribunal for a full hearing.
- **3. Linosan Packiyanathan** (Report No. 6824) Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4653021

## **DECISION:**

The Tribunal denied the renewal of Mr. Packiyanathan's Tow Truck Driver's Licence.
