The contractor will be performing the following work:

- Large service connection at 250 Heath Street.
- Branch connection at the intersection of Heath St and Tweedsmuir Ave.

WHAT TO EXPECT DURING CONSTRUCTION

• You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. Your patience is appreciated.

	Night Hours : will take place on September 14 th to 15 th and September 18 th to 19 th from 9:00 pm to 7:00 am. (Watermain & Service Connection)
•)	Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work area.
	Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times. Access for emergency vehicles will be maintained at all times.
8	Traffic Management : Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.
	Traffic on Heath Street will be reduced to one lane for the duration of construction activities.
R	Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. Please contact parking control for the location of your vehicle at 416-808-2222 .
	13K On-Street Parking Permit holders are asked to park elsewhere within the 13K parking zone (Heath Street West and Tichester Road from Bathurst Street to Spadina Road) to accommodate construction activity.
	Restoration: Areas affected by construction will be restored. Only the portions of road dug for the watermain trench will be restored; road resurfacing (from curb to curb) is not part of this project.
