

Purpose	To amend an existing temporary licence with Metrolinx at 2855 Eglinton Avenue West to include additional lands required, and to undertake the continuation of negotiations and discussions with the City, specifically PF&R, with respect to maintaining access from the pathway located on the Property to Eglinton Avenue West, and assignment to Metrolinx from the Toronto Transit Commission ("TTC") of the Terms of Use Agreement dated June 28, 2011 between the City and TTC within ninety (90) days following the execution of the amending Agreement., for the implementation of the Eglinton-Scarborough Crosstown Light Rail Transit Project (the "Project").					
Property	Part of City-owned land located at 2855 Eglinton Avenue West (the "Property"), shown as Part 1 on Sketch No. ECLE1-1-5K-907_CTS in Appendix "A" (the "Additional Lands").					
Actions	1. Authority be granted to amend an existing temporary licence with Metrolinx, dated July 23, 2015, over the Additional Lands, to include more lands for the construction of the Project, and to undertake the continuation of negotiations and discussions with the City, specifically PF&R, with respect to maintaining access from the pathway located on the Property to Eglinton Avenue West, and assignment to Metrolinx from the Toronto Transi Commission ("TTC") of the Terms of Use Agreement dated June 28, 2011 between the City and TTC within nine (90) days following the execution of this amending Agreement.					
	2. The appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.					
Financial Impact	There is no financial impact resulting from this approval.					
	Pursuant to Schedule F (Real Estate Protocol) contained in the Master Agreement between the City, the Toronto Transit Commission and Metrolinx for the implementation of the Toronto Light Rail Transit Program dated November 28, 2012 ("Master Agreement"), temporary use property requirements not required for City purposes are transferred to Metrolinx for nominal consideration.					
	The Deputy City Manager & Chief Financial Officer has reviewed this DAF and agrees with the financial impact information.					
Comments	The Additional Lands form part of Keelesdale Park and are required on a temporary basis for the construction of the Project. Under the Master Agreement established between Metrolinx, TTC and the City, Metrolinx has identified the subject property as a requirement for the Project.					
	The parties also undertake to continuing negotiations and discussions as indicated above, with respect to maintaining access from the pathway located on the Property to Eglinton Avenue West, and assignment to Metrolinx from the Toronto Transit Commission ("TTC") of the Terms of Use Agreement dated June 28, 2011 between the City and TTC within ninety (90) days following the execution of this amending Agreement.					
	PF&R has been consulted and has no objections with the amendment.
