Purpose	To obtain authority to enter into (i) a lease agreement (the "Lease") and a lease extension agreement (the "Extension Agreement") with Jae Soon Kim & Kookjo Kim c.o.b. as Domenic's Fish (the "Tenant") for Store No.14 (the "Leased Premises"), located on the ground level of the South St. Lawrence Market (the "Market"); (ii) an assignment and consent agreement (the "Assignment") with the Tenant and St Lawrence Fish Market Inc. c.o.b. as St Lawrence Fish Market (the "Assignee") regarding the Leased Premises; and (iii) an indemnity agreement (the "Indemnity Agreement") with Tom Antonarakis in favour of the City.

Financial Impact	<p>The City will receive total revenue of \$607,358.54 from Domenic's Fish (the "Tenant") for the total term of the lease from January 1, 2010 to December 31, 2019.</p> <p>For the period from January 1, 2010 to December 31, 2014, pursuant to the Lease, the City received semi-gross rent from the Tenant totaling \$286,456.16.</p> <p>For the period from January 1, 2015 to December 31, 2015, pursuant to the Extension Agreement, the City received semi-gross rent from the Tenant of \$59.11 per square foot totaling \$61,052.95.</p> <p>For the period from January 1, 2016 to December 31, 2016, pursuant to the Extension Agreement, the City received semi-gross rent from the Tenant of \$60.59 per square foot totaling \$62,581.59.</p> <p>For the period from January 1, 2017 to June 11, 2017, pursuant to the Extension Agreement, the City will receive semi-gross rent from the Tenant of \$62.10 per square foot totaling \$32,070.62.</p> <p>For the period from June 12, 2017 to December 31, 2017, pursuant to the Assignment, the City will receive semi-gross rent from the Assignee of \$62.10 per square foot, which rate shall increase by 2.5% on January 1 of every subsequent year of the term of the Extension Agreement, totaling approximately \$165,197.22.</p> <p>The Deputy City Manager & Chief Financial Officer has reviewed this DAF and agrees with the financial impact information.</p>

Comments	<p>The Market has been operated by the City of Toronto as a food market since 1903. Currently, 64 different tenants occupy approximately 47,000 square feet of rentable space in the Market.</p> <p>The Tenant has operated its business, Domenic's Fish, in the Market for almost 25 years since 1996. The Tenants are planning to retire and would like to sell the business.</p> <p>Tom Antonarakis, in trust for the Assignee, has entered into an agreement to purchase the business from the Tenant (the "Purchase Agreement"). The Assignee proposes to run the business under the name St. Lawrence Fish Market, and has committed to maintain the quality and popularity of the business which are acceptable to St. Lawrence Market Management.</p> <p>In order to satisfy the terms of the Purchase Agreement, the City has been requested to enter into the Lease and Extension Agreement with the Tenant, and the Assignment with the Tenant and the Assignee, incorporating current market terms and conditions. With the protection of the Indemnity Agreement, Real Estate Services staff are amenable to this request.</p>

General Conditions (“GC”)

- (a) The local Councillor (or local Councillors if the subject property is located on a ward boundary or if the transaction involves an exchange of properties in more than one ward), will be consulted prior to the exercise of delegated Approving Authority by staff for all Acquisitions, Disposals, Land Exchanges and Leases.
- (b) Where approving power has been delegated to staff, the Chief Corporate Officer, in consultation with the applicable Deputy City Manager or the City Manager, may determine that such matter is of such special interest that same should be returned to the relevant Committee and Council for consideration and determination.
- (c) Exercise of delegated authority is subject to all applicable Council policies, statutes or other applicable law.
- (d) Authority to approve financial commitments/expenditures is subject to all amounts being available in an approved budget, or funding being available from third party sources, except for "Strategic Property Acquisitions" as set out in EX44.22 adopted by Council August 25, 26, 27 and 28, 2014, which identifies alternative funding mechanisms subject to additional approval requirements.
- (e) Property interests are to be based on appraised value, and no interest shall be granted at less than market value unless otherwise specifically authorized.
- (f) Authority to approve transactions at less than market value is subject to statutory anti-bonus provisions.
- (g) Total compensation means the aggregate of all types of payments, including land value, estimated clean-up costs, potential arbitration awards, loss claims, etc, but exclusive of any applicable taxes and registration costs.
- (h) Authority to acquire property is conditional upon provision being made to bring the property into compliance with applicable MOE or other requirements such that it will be fit for its intended municipal purpose, except for property acquisitions of 50M² or less for transit shelter purposes.
- (i) Authority to initiate the permanent road closure process in **A.4** is conditional upon confirmation by the GM of Transportation Services that it is feasible to permanently close the highway.
- (j) Disposal authorities in **A.7** are subject to the property having been declared surplus, and the disposal policy complied with.
- (k) Land exchanges, except for those in **A.8**, may be authorized based on the delegated Approving Authority for Disposals in **A.7**.
- (l) Approving Authority with respect to land located in the Designated Waterfront Area is conditional upon the approval of the Director, Waterfront Secretariat.
- (m) Authority to approve an exchange of land in **A.8** is conditional upon confirmation by the Chief Planner and Executive Director, and the GM of Parks, Forestry & Recreation, that the land being exchanged is (i) nearby land of equivalent or larger area, and (ii) of comparable or superior green space utility.
- (n) Approving Authority in **A.9** Leases (City as Landlord) but not Licences (City as Licensor) is limited to periods (including options/renewals) of less than twenty-one (21) years.
- (o) Total compensation in leasing matters where the City is landlord (**A.9**) includes the value of tenant improvements if factored into tenant's rental payments.
- (p) Total compensation in leasing matters where the City is the tenant (**A.10**) includes the value of any tenant improvements to be paid by the City.
- (q) Where options/renewals are included in leases, if the renewal rent is to be determined at a date later than the original approval date, total compensation is to be calculated as though all options are exercised, estimating the renewal rent based on the highest rent payable in the first term of the lease.
- (r) Total compensation in leasing matters where the City is landlord (**A.9**) or tenant (**A.10**) is to be calculated from the date of approval pursuant to this delegation (ie. first allowing for the expiry of any prior approvals, whether by Council or a delegated authority).
- (s) Approving Authority in leasing matters includes authority to approve renewals/extensions within the parameters of the delegated Approving Authority.
- (t) Approving Authority includes authority for amendments within the parameters of the delegated Approving Authority, the cumulative total of which may not exceed the delegated financial limit.
- (u) Where proposed additional amounts in **A.13** exceed 10 per cent of the original decision, even if otherwise in compliance with all other conditions, then approving authority is transferred upwards to the next more senior level of approving authority having the relevant overall financial limit.
- (v) Approving Authority includes authority for all documents necessary to implement the authority, on terms and conditions satisfactory to the Approving Authority, in consultation with the relevant operating Division(s).
- (w) Staff positions referred to in this delegation include successors from time to time.
- (x) Documents are to be in a form satisfactory to the City Solicitor (including indemnity and insurance provisions).
- (y) Delegated signing authorities in **B** are conditional upon the documents having received the City Solicitor's prior "Approval as to Form".
- (z) This delegation does not affect sales, acquisitions and leases over which the Affordable Housing Committee has responsibility.
- (aa) Authority to use land acquired by the City for parking purposes by the Toronto Parking Authority is conditional upon Council enacting a by-law designating such use.
- (bb) All residential leasing documents shall adhere to the *Residential Tenancies Act* and any successor legislation.
- (cc) Despite GC(n), Approving Authority in residential leasing matters is not limited to periods of less than twenty-one (21) years.

Main Terms and Conditions

The Lease with the Tenant provides for the following main terms and conditions:

1. Tenant: Jae Soon Kim & Kookjo Kim c.o.b. as Domenic's Fish
2. Leased Premises: Approximately 1,032.87 square feet (including store area and temporary area)
3. Term: January 1, 2010 to December 31, 2014
4. Semi-gross rent:
 - a. \$52.90 per square foot of Rentable Area per annum for the period from the Lease Commencement Date to December 31, 2010. The Semi-Gross Rent will be subject to CPI increases from January 1, 2011 onwards.
5. Use: The Tenant shall use the Leased Premises for the sale at retail of:
 - o Fresh and frozen fish and seafood and related products
 - o The Tenant may also sell Domenic's Fish souvenir items, provided no more than two (2) such items are on sale at any one time and provided further that both the Tenant's trade name and the St. Lawrence Market name are displayed on such products

The Tenant shall not use the Leased Premises for any other purposes whatsoever.

6. Insurance: The Tenant shall throughout the Term, at its sole cost and expense, take out and keep in full force and effect, with the Landlord as an additional insured, all risks property insurance, business interruption insurance, crime insurance, and commercial general liability insurance including products liability, personal injury, employer's/and contingent employer's liability, tenant's legal liability, blanket contractual liability and provisions for cross liability and severability of interests and non-owned automobile liability with limits of not less than Two Million Dollars (\$2,000,000.00) per occurrence.
7. Indemnity: The Tenant shall indemnify and save harmless the Landlord from any and all liabilities, damages, costs and expenses, claims, suits, or actions incurred by it as a result of: any breach, violation or non-performance of any covenants, condition or agreement set forth and contained in the Lease; any damage to property occasioned by the Tenant's use and occupation of the Leased Premises; and any injury to persons, including death, occurring at any time in or about the Leased Premises and/or on the sidewalks, laneways or streets adjacent to same, unless the same is directly caused by the negligence of the Landlord.

The Extension Agreement with the Tenant amends the Lease as follows:

1. Term: January 1, 2015 to December 31, 2019 with no option to extend
2. Semi-gross rent: \$59.11 per square foot per annum commencing on January 1, 2015, subject to a 2.5% increase on January 1 of every subsequent calendar year during the Term of the Extension Agreement

The Assignment with the Tenant and the Assignee provides for the following main terms and conditions:

1. Assignor: Jae Soon Kim & Kookjo Kim c.o.b. as Domenic's Fish
2. Assignee: St Lawrence Fish Market Inc. c.o.b. as St Lawrence Fish Market
3. Date of closing: June 12, 2017
4. The City consents to the assignment of the Lease from the Assignor to the Assignee on the terms and conditions of the Assignment.

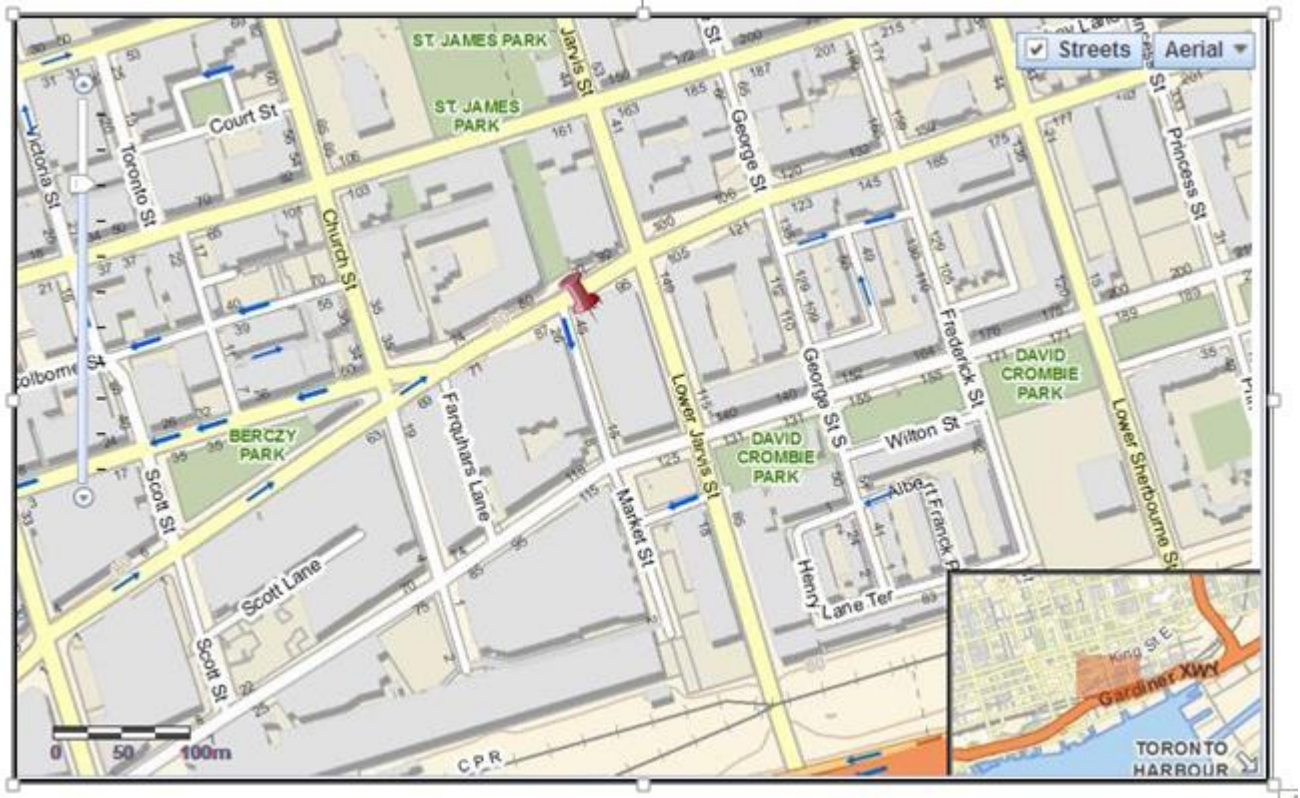
The Indemnity Agreement with Tom Antonarakis (the "Indemnifier") provides that:

1. The Indemnifier shall pay all rent, charges, and any other amounts payable by the Tenant under the Lease.
2. The Indemnifier shall promptly perform and complete all of the terms, covenants, and conditions to be kept, observed, and performed by the Tenant under the Lease.
3. The Indemnifier shall indemnify and save harmless the City from any loss, costs, or damages resulting from any default by the Tenant under the Lease.
