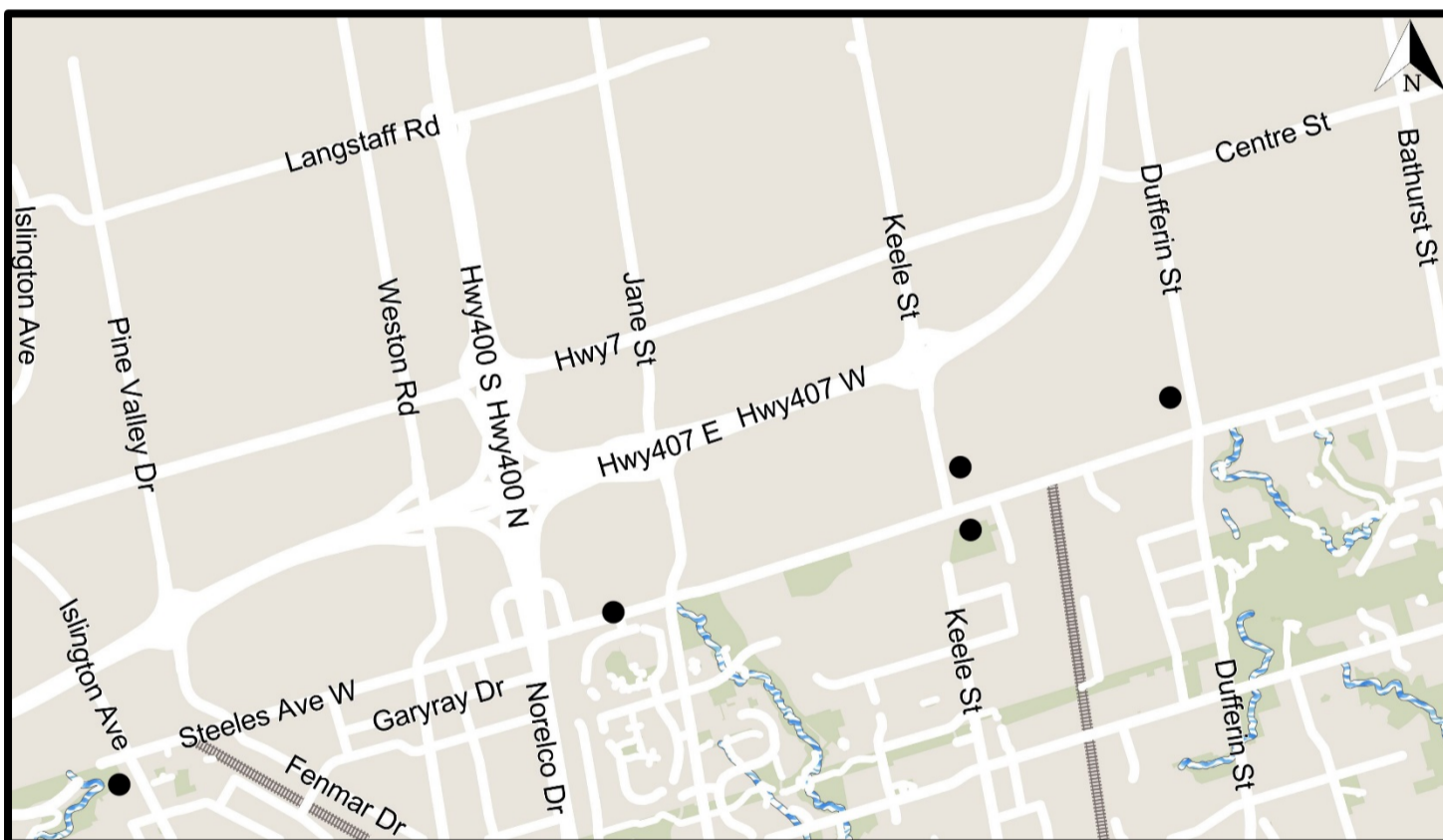
## Various Watermain Flow Meter Chamber Upgrades Across the City

**Contract #: 16ECS-LU-03TT**  
**Expected Start Date: Late November 2017**  
**Expected End Date: Late July, 2019**  
*\*Timeline is subject to change.*

The City of Toronto will be upgrading flow meters located in chambers at various locations. You are receiving this notice as one of the meters planned to be replaced is located near your home/business. The Flow Meter Chamber Upgrade work will take approximately 1 to 3 weeks to replace each meter. Work may not occur continuously during this period, and the work sequence listed below is subject to change.

This cost sharing project is part of the Council-Approved 2017 Capital Works Program to renew and modernize inter municipal water billing for the City of Toronto, York Region and its local municipalities.

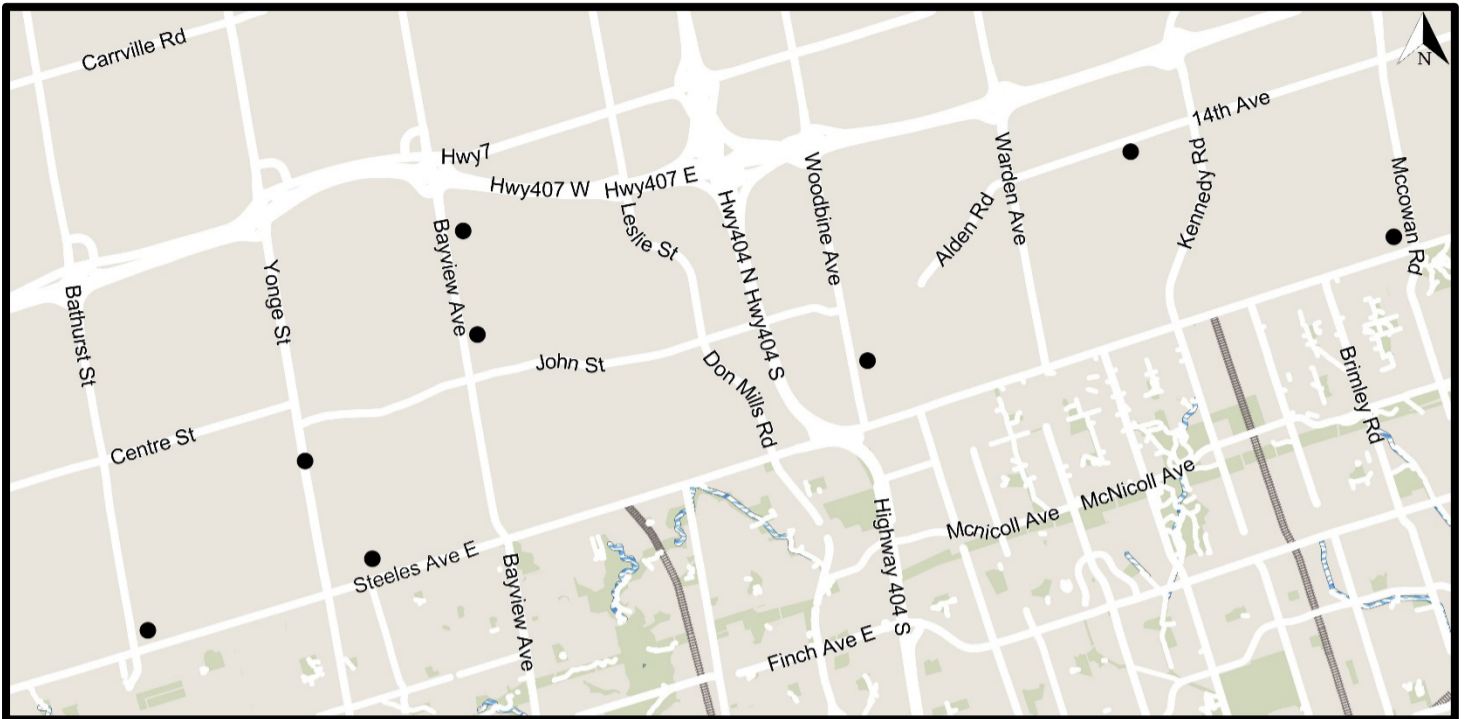
### Work Area Maps Steeles Avenue West

## Steeles Avenue East



The following Chambers are located within the road allowance, and may impact traffic.

5. Elgin St at Yonge St	Feb 15, 2018
6. Willowdale Blvd at Highland Park Blvd	Jan 25, 2018
7. Woodbine Ave at Steelcase Rd E	Aug 14, 2018
8. McCowan Rd at Steeles Ave E	Sep 17, 2018

More details will be issued two weeks before work in these areas take place.

The following chambers located within the Pumping Station Boundaries and work will NOT impact traffic.

9. 14 <sup>th</sup> Ave and Kennedy Rd (4 sites within Milliken Pumping Station)	May 7, 2018
10. Keele St at Steeles Ave W (north side)	Feb 18, 2019
11. Keele St at Steeles Ave W (south side)	Dec 3, 2018
12. Bayview Ave at Sycamore Dr (adjacent to Bayview Pumping Station)	Nov 27, 2017
13. Bayview Ave at Green Ln (adjacent to Thornhill Pumping Station)	Jan 4, 2018

**Note:** Sites are listed from West to East. Sequence of work might vary.







### **WORK DETAILS**

The City's contractor will:

- Install temporary fencing surrounding the watermain chamber
- Install the electrical and monitoring cabinet in the boulevard
- Replace the flow meter and complete other essential repairs inside the chamber.
- Where the underground flow meter chambers are located within the paved portion of the road, temporary lane closures will take place. Efforts will be made to minimize traffic disruption

## WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.

	<p><b>Work Hours:</b> Work will take place between 7:00 am to 7:00 pm., Monday to Friday, with work after hours and on weekends as required.</p>
	<p><b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p><b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p><b>Accessible Accommodation:</b> Residents who require accommodation (level entry, longer notice, etc.) must contact the <b>Project Manager</b> to arrange for access during the construction period.</p>
	<p><b>Traffic Management:</b> Where work is within road, efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect minor delays and increased traffic on nearby main and side streets.</p>
	<p><b>Garbage &amp; Recycling:</b> Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <b><i>Please ensure that you label your bins with your address.</i></b></p>
	<p><b>Restoration:</b> The construction work area will be restored with trees, shrubs, sod, seed, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
