Watermain Replacement on Plateau Crescent

Contract #: 17ECS-LU-12SU Start Date: September 11, 2017 End Date: December 2017 Revised Date: June 2018 *Timeline is subject to change.

Due to upcoming winter holidays, the City of Toronto will stop work for two weeks on Plateau Crescent. The City will return to re-start work on January 8 2018.

All underground work will be completed by the end of March 2018. Final restoration work will be completed by the end of June 2018.

This project is part of the Council-approved 2017 Capital Works Program to renew our aging infrastructure, improve water distribution and reduce the risk of watermain breaks.

WORK DETAILS

To date the contractor has:

- Installed and tested the new watermain
- · Completed a section of the service connections

The contractor will complete:

- Remaining of any City-owned water service pipes that do not meet City standards from the water main to the private property line
- Decommissioning the old watermain
- Restoration of all work areas with asphalt, concrete and/or grass

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. Your patience is appreciated.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and / or decorative objects.
- If you have a sprinkler system within the boulevard, please contact the Field Ambassador. The City will not be responsible for damage to any privately owned items on City property.

	Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work area.
	Water Service Disruptions: From time-to-time, the water supply to your property will be shut-off to complete construction; the contractor will provide at least 24-hour advance notice. Throughout the work, it is recommended that you temporarily disconnect any water treatment systems (i.e. softeners or filters), water-cooled air conditioners or similar plumbing fixtures. Automatic lawn sprinkler systems may also be affected, therefore, you may need to water manually. In the event you did not received advanced notice, <i>emergency water shut off</i> could have been necessary.
	Work Hours : Work will take place from 7:00 a.m. to 9:00 p.m., Monday to Friday, with work after hours and on weekends as required.
