# TORONTO LICENSING TRIBUNAL: February 8, 2018 Summary of Decisions A.N. Alibhai / M. Laverty / D. Simon

1. Laxman Ramdhari Singh (Report No. 6781) Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4315568

#### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

Tow Truck Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of two (2) years;
- (3) Prior to each of the next two (2) renewals of the licence, Laxman Ramdhari Singh must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Laxman Ramdhari Singh, those matters and report no. 6781, and any updating material, may be brought back before the Tribunal for a full hearing.
- **2. Dharamdeo Singh** (Report No. 6909) Applicant for the Renewal of Public Garage Licence No. B68-4651256

#### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

Public Garage Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Prior to the next licence renewal date on June 20, 2018, all outstanding and overdue City of Toronto by-law fines shall be paid in full, and proof of payment shall be submitted to Municipal Licensing and Standards.

- (1) All fees, documents and/or any outstanding requirements including Samuel Belay's up-to-date contact information must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years;
- (3) Prior to each of the next three (3) renewals of the licence, Samuel Belay must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Samuel Belay, those matters and report no. 6889, and any updating material, may be brought back before the Tribunal for a full hearing.

4. Estate of Sidney Glass (Report No. 6972) Stanley Glass, Estate Trustee Holder of Taxicab Owner's Licence No.: V02-4738421, Taxicab Plate No. 2839

## **DECISION:**

The Tribunal extended Taxicab Owner's Licence No. V02-4738421 for Taxicab Plate No. 2839 to remain in the Estate of Sidney Glass to June 8, 2018 on consent of both parties.

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Building Renovator's Licence will be placed on probation for a period of four (4) years;

- (3) Prior to each of the next four (4) renewals of the licence, Behzad Eftekhari must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date police record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 2449244 Ontario Inc. or Mr. Eftekhari, those matters and report no. 6904, and any updating material, may be brought back before the Tribunal for a full hearing.
- **7. Harpreet Sidhu** (Report No. 6913) Applicant for a Tow Truck Driver's Licence (Application No. B725605)

### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

(1) The matter will be adjourned sine die pending the resolution of criminal charges in court. Mr. Sidhu will inform Municipal Licensing and Standards of the outcome of the criminal proceedings, and Municipal Licensing and Standards will undertake to schedule a prehearing or to bring the matter back before the Tribunal forthwith, subject to the outcome of the criminal proceedings and to any subsequent investigation into the application that might be required.

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being renewed, Tow Truck Driver's Licence will be suspended for a period of two (2) days.

- (3) Upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of one (1) year;
- (4) Prior to next one (1) renewal of the licence, Jason Azzopardi must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Jason Azzopardi, those matters and report no. 6715, and any updating material, may be brought back before the Tribunal for a full hearing.
- **9. Irsalan Shakir Riaz** (Report No. 6927) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B730328)

#### **DECISION:**

The Tribunal adjourned this matter to April 5, 2018, peremptory to Mr. Irsalan Shakir Riaz.
