Sanitary Trunk Sewer Rehabilitation From Echo Valley Park to the Islington Golf Course

Contract #: 16ECS-LU-05TT

Start Date: October 2017

Expected End Date: Summer 2018

The City of Toronto's work to rehabilitate the North and the South Mimico sanitary trunk sewers (STS) from Echo Valley Park, near Wingrove Hill and Kipling Avenue, to the Islington Golf Course continues.

In order to complete a portion of the rehabilitation work, lane closures are needed and described below and the map on page 4.

- **From February 28, 2018 to March 2, 2018, between 7:00 PM and 6:00 AM, Kipling Avenue will be reduced to ONE lane in each direction near Wingrove Hill.**
 - The Left turn on Wingrove Hill from Kipling Avenue will not be permitted during this period to prevent traffic backup.
 - Vehicles on Kipling Ave will be able to access Wingrove Hill following a temporary detour D-1 through Tasker Road and Haliburton Avenue as per the map, signs will be posted.

- **On March 2, 2018 and March 4, 2018, between 7:00 PM and 6:00 AM, the eastbound lane of Wingrove Hill will be closed for traffic.**
 - Local traffic on Wingrove Hill will be able to access Kipling Avenue following a temporary detour D-2 through Haliburton Avenue and Tasker Road as per the map, signs will be posted.

All dates are subject to change due to weather and other circumstances. Thank you for your patience during this phase of construction.

WORK DETAILS

To date, the contractor has completed the following work:




- Essential tree removals, installed tree protection fences for nearby trees, installed temporary access path for construction and currently constructing a pit and installing temporary sewer bypass pipes.






Ongoing and next phase work:

- Complete temporary sewer bypass installation to divert flow from the sewer to the temporary pipes to facilitate sewer repairs.
- Temporary pumps will operate for approximately 30 to 40 days, during February to April 2018 mostly during the day.
- The noise generated due to operation of these pumps is low, based on the City's experience with similar projects.
- Re-line the sewers using a trenchless method; a sock filled with resin will be inserted into the pipe through the sewer maintenance hole and is cured in place with steam for 8-10 hours the end result is a new pipe formed within the existing pipe

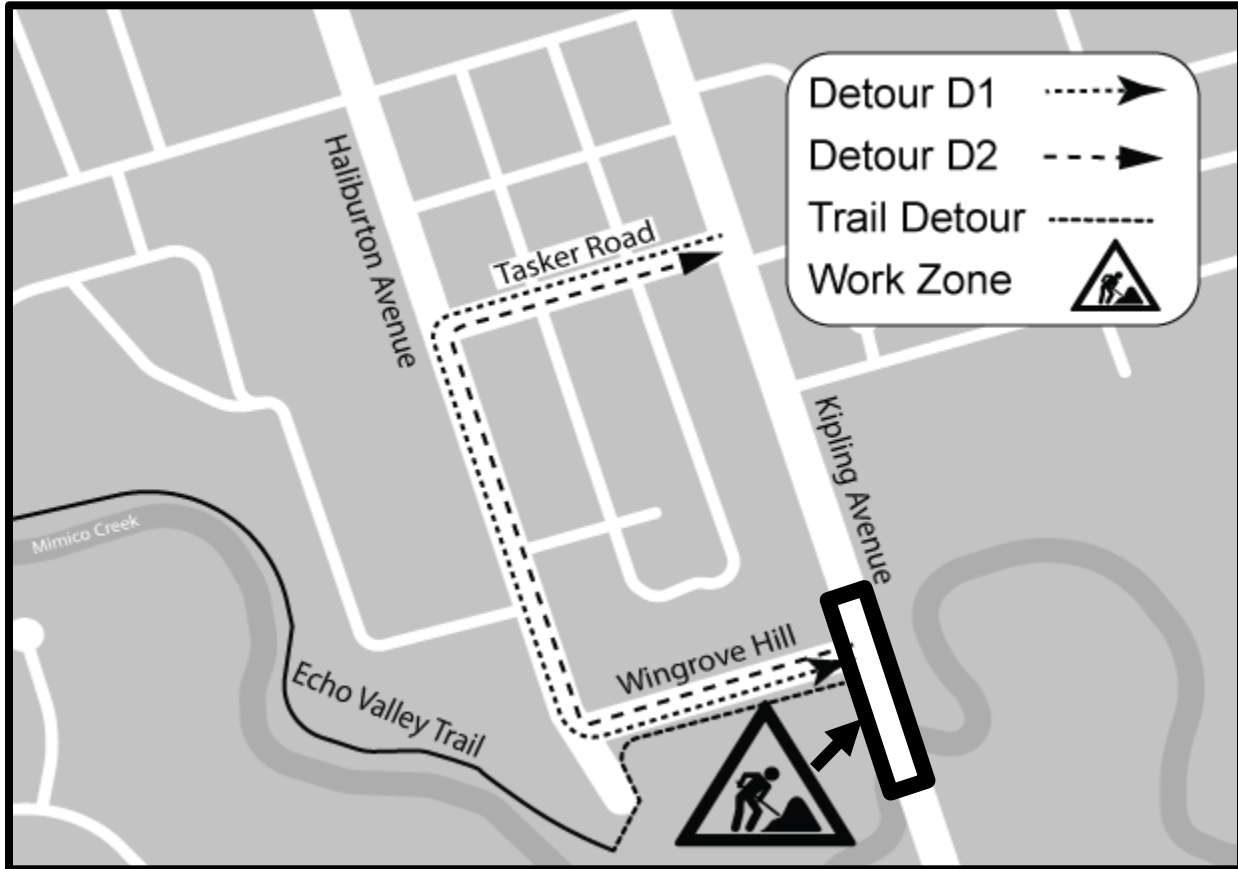
WHAT TO EXPECT DURING CONSTRUCTION:

- You may experience dust, noise, trail closures, and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- Property owners should remove items located within City property limits (boulevard & easement), such as landscaping and / or decorative objects. If you have a sprinkler system within the boulevard and/or City easement, please contact the Project Manager.
- The City will not be responsible for damage to any privately owned items on City property or on the easement.

	<p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect minor delays and increased traffic on nearby main and side streets. The traffic impacts are detailed on page 1.</p>
	<p>Cyclists: Cyclists travelling on Kipling Ave between Burnhamthorpe Rd and Bywood Dr must dismount their bikes within the construction zone and walk with their bicycles on the pedestrian sidewalk at the east side of Kipling Ave.</p>
	<p>Work Hours: Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday. However, the sewer lining curing process once initiated takes 8-10 hours and the temporary sewer bypass pump and construction work may continue for extended hours.</p>

	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Accessible Accommodation: Residents / businesses that require accommodation (level entry, wheel trans entry etc.) must contact the Project Manager to arrange for access during the construction period.</p>
	<p>Park / Trail Access: For public safety and to separate the construction work from public, a portion of the Echo Valley Park and Mimico Trail from Wingrove Hill to Echo Valley Road is temporarily closed for the duration of the project. Detour and Closure signage have been installed to help trail users.</p>
	<p>Garbage & Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <i>Please ensure that you label your bins with your address.</i></p>
	<p>Restoration: The construction work area will be restored with trees, shrubs, sod, seed, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
